In order to maintain Law & Order, peace and tranquility and to prevent incidents of breach of peace and in exercise of the powers vested in me U/s 144 Cr. PC, I, Anjani Kumar, IPS, Commissioner of Police, Hyderabad City hereby prohibit assembly of (5) or more persons in a radius of 100 meters at the above places on **18-03-2019 to 28-03-2019** in connection with Nominations and last date of withdrawal.

As per the guidelines of Election Commission of India, the following directions are issued for maintenance of effective law & order and security arrangements for the above process.

- 1) The maximum number of vehicles to be allowed to come within a periphery of 100 meters of ROs Office has been restricted to (3) three.
- 2) The maximum number of persons that can be allowed to enter the office of ROs at the time of filing nomination has been limited to (5) five (including the candidate).

The Public are hereby informed that any person violating the above orders shall be liable for prosecution.
