TRAFFIC ADVISORY

STATEMENT OF DCP, CENTRAL ZONE ON THE INCIDENT OF ASSAULT OF A SENIOR PAEDIATRICIAN UNDER NARAYANGUDA PS LIMITS

An incident of assault of a senior paediatrician was reported in Narayanaguda PS on the night of 28-12-2018 at about 9.10 pm. Two unknown persons beat up Dr. Michael Aranha while he was in his clinic at Lingapur Building, Himayath Nagar. A case has been registered on the complaint of the doctor u/s 448 (House Trespass) and 326 (Voluntarily causing grievous hurt by dangerous weapons or means) of IPC and Section 4 of Telangana Medicare Service Persons and Medicare Service Institutions (Prevention of Violence and Damage of Property) Act, 2008. The TWO accused persons have been identified in no time by forming special teams and arrested immediately on 30-12-2018. The arrested accused have been remanded to the judicial custody. The motive for the offence appears to be a case of communication gap between the doctor and the accused while the latter along with his wife went to the doctor for consultation for their child at about 7 pm on 28-12-2018.

During the course of consultation, the accused felt that the doctor wasn't paying attention to him and only speaking with his wife and thought it to be an act of insulting the modesty of his wife. He returned to the clinic later around 9.10 pm along with his friend and assaulted the doctor. The prime accused perceived the conduct of the doctor to be objectionable, but surprisingly he didn't raise it at the time of consultation. The paediatricians normally interact with the mothers to elicit information about the child during the consultation which is quite normal. The case is under investigation and the charge sheet will be filed soon in the court of law.
