CONDUCTED RAID AT GAMING HOUSE - 12 PERSONS HELD

On 05-01-2019, in the night hours on credible information the sleuths of Commissioner's Task Force, North Zone Team conducted raid at Gaming House. No. 963, Kalasiguda, Bollaram, Secunderabad and apprehended **(12) accused persons** in which (01) Gaming Organizer & (11) Punters. Where in the Gaming organizer Paderu Darmesh, age. 50 yrs, occ. Car driver is organizing gambling (three card) and use the above premises as common Gaming house. **Seized Gaming amount Rs. 1, 87,600/- (One lakh Eighty seven thousand and six hundred only)**, Cell phones-13, 3 sets of play cards, One ground sheet from the possession of accused persons.

➤ **FACT OF THE CASE :-**

The accused Paderu Darmesh, aged about 50 yrs is residing at H. No. 963, Kalsiguda, Bollaram, Secunderabad. He is a car driver for his livelihood. He is habit of playing three card game by betting money. His earnings are not sufficient to lead lavish life, hatched a plan to run gaming house by invite punters who are habit of playing three card by betting money. From few days he is organizing Gambling at his own house premises at H.No. H. No. 963, Kalsiguda, Bollaram, Secunderabad and use the premises as Gaming house. He is inviting Punters who are in habit of playing three card game by betting money, which is a game of Chance and collecting amount

Rs. 500/- from each punter for allow into gaming house for playing three card game and gain easy money illegally.

On 05-01-2019 in the night hours while the organizer Paderu Darmesh along with eleven punters are playing three card gambling by betting money at above said place, on tip off information under supervision of Sri. K.Nageswar Rao, Inspector of Police, Commissioner's Task Force, North Zone along with team conducted raid on the gambling house and apprehended (12) accused persons including (01) Gaming organizer & (11) punters.

Seized Gaming total amount Rs. 1, 87, 600/-, Cell phones-13, 3 sets of play cards & one Ground sheet from the possession of above accused persons.

The apprehended accused persons along with seized material handed over to SHO, Bollaram PS for taking necessary legal action against them as per law. Vide Cr.No. 02/2019, U/Sec. 3&4 of Gaming Act.

The apprehension was made under the supervision of **Sri. Sri.P.Radhakishan Rao,Dy.Commissioner of Police**, Commissioner's Task Force, Hyderabad by Sri K.Nageswar Rao, Inspector of Police, North Zone Task Force, and the SIs Sri.
