

**SEIZURE OF ILLEGAL FIRE ARM**  
**01-COUNTRY MADE PISTOL & 05-LIVE ROUNDS - ONE HELD**

On 06-12-2018, on credible information the Commissioner's Task Force, East Zone Team, Hyderabad, apprehended one accused **Odela Srinivas**, who is in illegal possession of **01- Country made Pistol and 05-Live Rounds** in the limits of PS Kanchanbagh, Hyderabad.

**Accused Persons Details:-**

Odela Srinivas s/o Late Laxmaiah, age 42 yrs, Occ: Auto Driver, R/o Damodara Sanjeevaiah Nagar, Santosh Nagar, Hyderabad. N/o SC Colony, Kondapaka (V), Veenavanka (M), Karimnagar Dist.

**MODUS OPERANDI :-**

The accused, who was a Maoist sympathizer, hails from Karimnagar Dist. In the year 2001 he came to Hyderabad and eked his livelihood by doing Tailoring work. Recently he purchased a passenger auto rickshaw and living at Santosh Nagar, Hyderabad. In the year 2012 he purchased a house and due to financial crisis he mortgaged the said house for Rs.10,00,000/- with one Ashok.

Subsequently, he paid interest amount to the said loan to Ashok for 2 years and then onwards due to increased financial burden he stopped paying the interest. In this process, he decided to sell the said property through Ashok, but the said Ashok filed a case in the court stating that Odela Srinivas sold the property to him for Rs.10,00,000/-. In this process Odela Srinivas developed grudge on him and to eliminate him he went to Uttar Pradesh and procured one Country made pistol with 05-live rounds.

Today i.e., on 06-12-2018, on the tip off from **PC 6039 Sri M. Praveen Kumar** of Commissioner's Task Force, East Zone Team, Hyd., apprehended the above accused at his residence at Damodara Sanjeevaiah Nagar, Santosh Nagar, Hyderabad, and recovered 01-Country Made Pistol & 05-Live Rounds, from his possession.

The arrested accused is being handed over to SHO, Kanchanbagh PS, for taking further action.
