NABBED NOXIOUS CHEWING TOBACCO SALES & TRANSPORTING GANG- 2
HELD

Seized noxious Chewing Tobacco "Baba 120 Premium Chewing Tobacco" brand 330 tins & One Transporting Auto trolley. Seized material Market value about 1,50,000/-.

On 06-01-2019, the sleuths of Commissioner's Task Force, North Zone team, Hyderabad on credible information intercepted transport Goods Auto trolley bearing Reg No. AP13X 7129 (Bajaj Goods) near Begum bazaar X road, Shahinayathgunj PS limits, which containing **noxious chewing Tobacco** brand of "**Baba 120 Premium Chewing Tobacco**" **330 tins each weg 50 grams** and apprehended Two accused persons by name 1). Shaik Parvez (Transporting agent & Driver) **2**). Mohd Yousuf (Associate) where in the accused persons are illegal transporting and sale of banned Noxious Chewing Tobacco to known and needy customers on high price and gain illegal easy money.

➤ **NAME OF ACCUSED PERSONS :**

1. Shaik Parvez S/o. Shiak Yousuf, age. 28 yrs, Occ. Auto trolley driver, R/o. Attapur, Mahmoodabad, Rajendra Nagar, R.R Dist (Transport agent & Driver)
2. Mohd Yousuf S/o. late Adul Raheem, age. 30 yrs, Occ. Labour R/o. Palaskatta, Yakutpura, Hyderabad, (Associate).

➤ **SEIZED MATERIL:- Seized material market value about 1,50,000/-**

1. Baba 120 Premium Chewing Tobacco - 330 tins each weg 50 grams
2. Goods Auto trolley Reg no. AP13X 7129

➤ **BRIEF FACTS THE CASE :-**

Facts of the case are that, the accused Shaik Parvez S/o. Shiak Yousuf, age. 28 yrs, is residing at Attapur, Mahmoodabad, Rajendra Nagar, R.R Dist. He is running Good Auto trolley Reg No. AP13X 7129 for his livelihood. But his earning are not sufficient to lead lavish life, he hatched a plan to gain easy money illegal way. He used to transport and deliver of Noxious Chewing Tobacco, Zarda, Gutka products containing Tobacco contents and Nicotine as ingredients on the name of various brands in and around Hyderabad to known and needy customers and gain illegally easy money. He engaged one of his friend Mohd Yousuf as deliver agent on daily wage basis and accompany with the accused in transporting of Noxious Tobacco, Zarda of various brands etc .

The accused Shaik Parvez is purchasing the Noxious chewing Tobacco, Zarda, Gutak products from dealer/distributor by name Saleem R/o. Kalapathar, Hyderabad (absconding) and clandestinely transporting and deliver to sub dealers, known and needy customers, Kirana stores, Pan shop vendors in and around Hyderabad and others areas in high price and gain easy profits illegally.

Since, the Telangana State Government has banned the sale, manufacture, distribution and storage of Zarda, Gutka contains Tobacco and all its variants. After that the accused persons have planned to earning easy money by way of selling of banned Zarda, Gutkha in the market as it as much demand in the market. The accused persons violated the food safety and Standards Act 2006.

➤ **ARREST:-**

On 06/01/2019 in the night hours the accused Shaik Parvez along with his associate Mohd Yousuf while transporting the Baba 120 Chewing Tobacco brand Tobacco products in the Goods Auto Trolley Reg no. AP13X 7129 in order to deliver to needy customers meanwhile on credible information near Begum Bazar X road, in the limits of Shahinayathgunj PS limits intercepted the transporting Goods Auto Trolley and apprehended the above accused persons red handedly.

Seized Baba 120 premium Chewing Tobacco -330 Tins each weg 50 grams and one **Good Auto trolley Reg no. AP13X 7129** from the instance of accused persons and seized material **Market Value about Rs 1,50,000/-**.

The apprehended accused persons along with seized material handed over to SHO, Shahinayathgunj PS for further investigation. Vide Cr.No. 02/2019, U/Sec. 272, 272, 188 IPC & Sec. 20(2) of COTP Act of Shahinayathgunj PS.

**APPREHENDED PICKPOCKETER MIRZA RAHMATH BAIG WHO
COMMITTED THEFT FROM AFGHAN NATIONAL WHO CAME TO INDIA FOR
TREATMENT OF HIS SON - RECOVERED 1400 US \$ AND 5000 AFGHANI
CURRENCY WORTH ABOUT 1 LAKH IN INDIAN CURRENCY.**

On 07-01-2019, the sleuths of Commissioner's Task Force, South Zone Team, Hyderabad along with Hussainialam Police apprehended a pick pocketeer by name Mirza Rahmath Baig who committed theft of **1400 US \$** and **5000 AFGHANI CURRENCY** from Afghan national who came to Hyderabad for treatment of his son and recovered the entire cash intact from the accused.

Details of accused:-

Mirza Rahmath Baig S/o Mirza Maqbool Baig, age: 20 years, R/o H.No: 19-3-294/254/7, Near Nice Hotel, Vattepally, Hyderabad

Brief facts of the case:-

Syed Mirwais Rahimi, a native of Samangam (Village) Farasth Harsa Dist., Afganisthan came to Hyderabad on 29-12-2018 along with his six year old son Faiaz for eye operation at L.V. Prasad Eye Hospital. Earlier about six months ago, Faiaz underwent treatment at L.V. Prasad. On 04-01-2019 at 01:00 PM he came to Mecca Masjid for Friday prayers. He had 1400 US Dollars, 5000 Afgani currency in his Khurtha pocket. After completion of prayers, the accused Mirza Rahmath Baig observed the cash in the kurtha pocket of Mirwais Rahimi and taking advantage of the rush while leaving the Masjid, he committed theft of entire cash from Mirwais's kurtha.

The accused Rahmath Baig, is an old offender. He is involved in similar offences under the limits of Chandrayanagutta and Begumbazar. He has the passion of riding bikes and enjoying life by taking Hookah. As his family's financial position is weak, to accomplish his passion/habits he became an offender and leading lavish life with the stolen property.

In this case, in spite of trying at several places he failed to exchange the foreign currency. As such entire cash was recovered intact.

The apprehended offender Mirza Rahmath Baig along with recovered cash is handed over to the S.H.O. Hussainialam Police Station for taking further action.
