NOTIFICATION

In order to maintain Law & Order, peace and tranquility and to prevent incidents of breach of peace and accidents that are likely to occur unless kite flying is regulated during the celebration of Sankranthi Festival in Hyderabad City from 14-01-2019 to 15-01-2019. I, Anjani Kumar, IPS, Commissioner of Police, Hyderabad, in exercise of the powers vested in me Under Section 22 (1), (2) and (3) of Hyderabad City Police Act, 1348 Fasli (No. IX) do hereby order that kite flying on all thoroughfares and in and around places of worship be prohibited, in the interest of maintenance of public order.

Parents and Citizens of Hyderabad City have to advise their children for not to fly kites from the terraces, which do not have parapet walls, to avoid any untoward incident. They should also advise their children not to run on the roads or vulnerable places while flying kites or trying to collect stray kites. Children should be made aware of their vulnerability as regards electrocution, if they try to collect stray kites from electric poles.

The revellers shall not collect wood forcibly for bonfires and they should use wood only with the consent of owners.

Public are hereby informed that any person violating the above Orders shall be liable for Prosecution under the Hyderabad City Police Act, 1348 Fasli (No. IX).

This order shall be in force with effect from 0600 hrs on 14-01-2019 upto 0600 hrs on 16-01-2019.

PD ACT INVOKED AGAINST CHETAN SONI S/O LATE ANAND SONI, PROPERTY OFFENDER OF ABID ROAD POLICE STATION, CENTRAL ZONE, HYDERABAD.

Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City issued P.D. Orders against Chetan Soni S/o late Anand Soni, property offender of Abid Road Police Station on 22.12.2018.

Chetan Soni S/o late Anand Soni, aged about 23 years, un-employed, n/o H.No.19-1-911, Gollakhidki, Murali Nagar, behind Navender Bhavan, near St.Gabriel School, Hussainialam, Hyderabad, presently residing in Room No.5, M.S.Boys Hostel, King Koti, Shergate, Hyderabad has committed offences of thefts of **two wheelers, mobile phones and laptop under the limits of Hyderabad Police Commissionerate** to make easy money and lead a lavish life.

The accused has committed 5 offences in the recent past under the limits of Hyderabad Police Commissionerate and has been creating large scale fear and panic among the general public, thereby adversely affecting the public order, apart from disturbing the peace, tranquillity and social harmony in the society.

Abid Road Police made strenuous efforts and arrested the accused Chetan Soni S/o late Anand Soni on 6.10.2018 in Cr.No.239/2018 U/s 380, 109 IPC & 102 Cr.P.C of Abid Road Police Station and remanded him to judicial custody. The Preventive Detention Order was executed on him on 27.12.2018 and he was lodged in Central Prison, Chanchalguda, Hyderabad.

TRAFFIC ADVISORY
352nd BIRTH DAY CELEBRATIONS OF 10th SIKH GURU SHRI GURU GOBIND
SINGH
(SIKH RELIGIOUS PROCESSION)

Sikh religious people will takeout Sikh procession on 11-01-2019 at 03.00 pm onwards on the occasion of 352nd birthday celebrations of their 10th Sikh Guru Shri Guru Gobind Singh. The procession will starts from Central Gurudwara Saheb, Gowliguda and passes through the roads Shanker Sher Hotel - left turn - Gurudwara Guru Singh Sabha, Ashok Bazar - Gurunanak Mark – Afzalgunj Island – Afzalgunj ‘T’ Junction - Siddiamaber Bazar - Mojamjahi Market – Right Turn - Jambagh - Puthilibowli return to Central Gurudwara Saheb, Gowliguda. The expected gathering in this procession will be about 2000 Sikh devotees. In this regard, traffic diversions in the following routes are needed in the limits of Tr.PS.Sultan bazaar and Tr.PS.Goshamahal from 15.00Hrs to 23.00 Hrs on 11.01.2019.

Sl. No.	Name of Diversion point	Diversion instructions
1	Shivaji Bridge Junction	When the procession starts from Central Gurudwara Gowliguda, Afzalgunj the traffic coming from CBS towards Afzalgunj will not to be allowed and diverted towards S.J. bridge rotary / CBS.
2	Rammandir Gowliguda	When the procession starts from Central Gurudwara Gowliguda the vehicular traffic coming from Putlibowli towards Shanker Sher Hotel will be diverted towards CBS via. Ram Mandir Road.
3	Afzalgunj ‘T’ Junction	When the procession reach Afzalgunj ‘T’ Junction and proceed towards S.A. Bazar Mosque, all the vehicular traffic coming from Afzalgunj will be diverted towards State Central Library Afzalgunj – Shivaji Bridge – CBS - Rangamahal till the procession move to M.J. Market.
4	Rangamahal Junction	When the procession reach near MJ Market and turns towards Jambagh at that time the traffic coming from Charderghat will not to be allowed from Rangamahal Junction towards Jambagh and diverted towards CBS, SJ Bride. (if necessary)
5	Nayapool (Charminar Tr.PS.Limits)	When the processions reach Central Library, Afzalgunj the traffic coming from Madina and City College will not to be allowed towards Afzalgunj and diverted towards Salarjung Museum – S.J.Rotary.
6	Shanti Fireworks (Goshamahal Tr.PS Limits)	When the procession passed Shanthi Fireworks lane the traffic coming from Afzalgunj and intending to proceed towards MJ Market (or) so on will be diverted at Shanti Fireworks and they have to proceed taking left turn via Feel Khana – Right Turn – Top Khana - Alaska – Malakunta – Left Turn – Midas High School U Turn – MJ Market.

All the commuters are requested to take alternate routes to avoid delay and congestion and co-operate with Hyderabad Traffic Police.
