After the programme, the Hon'ble Vice President of India will proceed to his residence at Jubilee Hills, Hyderabad.

On 15-12-2018 (Saturday) at 1715 Hrs Sri. M. Venkaiah Naidu, Hon'ble Vice President of India will go to Telangana Kala Bharati (NTR Stadium) at 1725 Hrs and after the programme the Hon'ble Vice President of India at 1815 Hrs will leave for Taj Deccan Hotel, Banjara Hills and from there to his residence at 1845 Hrs at Jubilee Hills.

All citizens are requested to take note of above the programmes and plan their movements by taking alternative routes to reach their destinations during the specified dates & timings and co-operate with the Hyderabad Traffic Police.

**NABBED PSEUDO POLICE/CELL PHONE SNATCHING OFFENDERS – 2 HELD
4 cases detected, seized 6 mobile phones, two motor cycles & Rs.
4,600/-**

On 12-12-2018, on credible information the sleuths of Commissioner's Task Force, North Zone Team, Hyderabad, nabbed pseudo Police/Cell phone snatching offenders and apprehended (2) accused persons by name 1) Mohd Abbas (Main accused) & 2) Shaik Siraj (associate) and detected (4) cases i.e Hyderabad City-03, Cyberabad -01.

Details of apprehended accused persons:-

1. Mohd Abbas S/o. Mohd Chand Pasha, age. 31 yrs, occ. Centring work N/o. Kashipur (village), Kandi Mandal, Sanga Reddy Dist, Telangana State.
2. Shaik Siraj S/o. late Shaik Mahaboob, age. 27 yrs, occ. Mobile shop (SM Mobiles) N/o. Sanga Reddy Dist , Telangana State.

Property Recovered

- 1) Cell phones -06 (belongs to victims)
- 2) Net Cash of Rs. 4,600/-
- 3) Two motor cycles Reg no.AP31AG2214 (Pulsar), Reg.no.AP31AG2214(Unicorn)

Brief History of accused persons:-

The accused Mohd Abbas, age. 31 yrs R/o. Kashipur (village), Kandi Mandal, Sanga Reddy Dist. He is doing Centring work at Hyderabad for his livelihood. He is main accused.

The accused Shaik Siraj , age. 27 yrs R/o. Sanga Reddy Dist. He is doing cell phones repairs at his native place. He is associate of Mohd Abbas

Modus operandi:-

The accused Mohd Abbas is doing as a centring work from last three years and other accused Shaik Siraj doing cell phones repair, but their

earnings are not sufficient for their luxurious life. Hence the both accused persons decided to gain easy money in illegal ways by committing cell phones/Cash theft by diverting the attention of victims, posing themselves as Police officers/Vigilance officers.

As per their plan they started moving on their pulsar /Unicorn vehicle to commit offences. while moving on their motor cycles on the way they select the innocent persons who are going on the road and target them, wontedly starts quarrelling with them, forcibly take the cell phones/money by diverting the attention of victim and left the spot with the stolen property.

So far they have committed (4) offences in the limits of Begunmpeta PS -01, Ramgopalpet PS-01, Nampally PS-01 of Hyderabad & Ramachandrapuram PS -01 of Cyberabad.

ARREST:-

Today i.e. on 12-12-2018, on credible information apprehended the accused person 1)Mohd Abbas & 2) Shaik Siraj and **seized i.e 6 Cell phones, 2 Motor cycles Reg no. Reg no.AP31AG2214 (Pulsar), net cash of Rs. 4600/-** from their possession.

The accused persons along with recovered property were handed over to SHO, Begumpeta PS for further investigation.

The arrest was made under the supervision of **Sri.P.Radhakishan Rao, Dy.Commissioner of Police**, Commissioner's Task Force, Hyderabad by Sri K.Nageswar Rao, Inspector of Police, Commissioner's Task Force, North Zone, and SIs Sri.
