Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City issued P.D. Orders against Mohammed Azad @ Chacha @ Dudu Miyan @ Basha Khan @ Azad Chowdhary S/o Late Abdul Rasheed Chowdhary @ Mohammed Rasheed Khan "**White Collar Offender**" of Afzalgunj Police Station on 2.12.2018.

Mohammed Azad @ Chacha @ Dudu Miyan @ Basha Khan @ Azad Chowdhary S/o Late Abdul Rasheed Chowdhary @ Mohammed Rasheed Khan, aged about 31 years, Occ: Labour, R/o H.No.3-4-937/116/116/A, Ratna Nagar, Barkatpura, Kachiguda, Hyderabad, N/o Kalighat area, Baligram (village & post), Malda town, West Bengal has committed offences of **cheating by diverting attention of innocent people in the limits of Hyderabad Police Commissionerate** in an organized manner to make easy money and to lead a lavish life.

The detenu has committed **5 Cheating offences** by diverting attention under the limits of Hyderabad Police Commissionerate and he has been creating large scale fear and panic among the general public, thereby adversely affecting the public order, apart from disturbing the peace, tranquillity and social harmony in the society.

Afzalgunj Police made strenuous efforts and arrested the detenu Mohammed Azad @ Chacha @ Dudu Miyan @ Basha Khan @ Azad Chowdhary on 28.9.2018 in Cr.No.296/2018 U/s 420, 379, 120 (B) IPC of Afzalgunj PS and remanded him to judicial custody. The Preventive Detention Order was executed on him on 3.12.2018 and he was lodged in Central Prison, Chanchalguda, Hyderabad.

**THE SENSATIONAL MURDER CASE OCCURRED NEAR NAYAPOL AUTO ADDA  
HAS BEEN SOLVED, THE POLICE MIRCHOWK ARRESTED THREE MORE  
ACCUSED PERSONS INVOLVED IN THE MURDER**

**( Accused persons A-3 to A-5 arrested on 13-12-2018 at 1550 hrs and being produced in the Hon'ble court )**

The accused A-2 Mohd., Imtiyaz has 10 passengers auto , who used to give on rental basis to auto drivers for a daily rent of Rs.500, whereas the deceased Mohammed Shakeer, who also owns 5 passenger autos used to lend his autos on deily rental baises for a rend of Rs.300/-. The auto drivers used to prefer to take autos from the deceased, comparatively to the accused A2, as a result of which business rivalry arose between the accused A-2 and deceased, and the accused A-2 was looking for opportunity to remove the deceased, who has joined the auto line recently nearly about 9 months.

Apart from the above issue, One Mr. Aqeel, who is the son of deceased elder brother, was developed friendship with accused A1, and was moving with him vagabondly consuming alcohol. The deceased who is caretaker of the said Aqeel warned him, and also warned accused A1. On 27-11-2018 at about 2100 hrs, the deceased along with others approached accused A-1 at near Nayapool auto adda . There deceased and his followers abused A1 in filthy language and some heated arguments took place between them. On noticing the same the accused persons A-3 to A-5 interfered and tried to pacify them. On the same night, the accused A-2 met A-1 and he instigated A-1 by saying that Shakeer has become trouble monger in his business and as well as Shakeer has developed personnel grudges on A-1 on the issue of Aqeel and waiting for the chance to take revenge on him. Further A-2 also instigated A-1, that to eliminate Shakeer, so that it can helpful in his business and A-2 also promised that he can assist A-1 through finance for purchasing of new passenger auto. Upon which A-1 informed A-2 that he will kill Shakeer. The accused A-1 hatched plan to kill Shakeer for which he procured one nickel punch and one knife with pouch. The accused A-1 disclosed his plan to his friends/accused persons A-3 to A-5 and requested them to help him in order to kill Shakeer for which they agreed to co-operate with A-1 in offence, for which A-1 have promised them with cash or any other benefit. On 28-11-2018 at about 1500 hrs, accused A-1 met with A-3 and they both went to wine shop situated at near Santoshi matha temple, Afzalgunj, where they consumed alcohol and discussed regarding execution of plan. After consuming alcohol, at about 1830 hrs, accused persons A-1 & A-3 returned back to auto adda, Nayapool. After reaching near Nayapool auto adda the accused A-4 & A-5 also met them. The accused A-1 instructed A-3 to A-5 to threaten the public, whoever comes to stop him for smooth execution of his plan. On arrival of deceased - Shakeer, the accused A-1 approached towards him and they both has chit chatted over the issue of Aqeel and some heated arguments taken place in between them. Meantime all of sudden the accused A-1 attacked on Shakeer with knife and several times stabbed in his stomach. In order to save his life Shakeer (deceased) tried to escape from accused A-1 clutches and ran towards ICICI Bank side with bleeding injuries. On that the accused A-1 chased and continued to attack him with knife and stabbed him on several of parts his body. When the deceased fell on the road, accused sat on him and started cut his throat with knife and continued to cut deceased neck several times. The injured Shakeer died on the spot with severe bleeding injuries. While attacking Shakeer, the accused A-1 received cut injury on his right hand index finger. While A-1 was attacking on deceased, the other accused persons A-3 to A-5 has roamed nearby to the scene of offence and kept sharp watch over the movements of road passers and others who were trying to stop A-1. While A-1 was attacking on Shakeer the road passers tried to stop him, but he threatened them on the point of knife. After confirming that Shakeer has died, A-1 called A-4, handed over the knife which was used in the commission of offence and his cell phone to him. After collecting the knife, cell phone the accused A-4 thrown away the knife in Moosi River and concealed the cell phone in his house.

On the above incident, a case in Cr. No. 218/2018 was registered at PS Mirchowk and investigated into. During investigation the accused A1 was arrested and recorded his confession, and produced him before the court and was remanded. During further investigation of the case, the CCTV footages were examined, and noted the physical features of the other accused who were

involved in the offence, and made efforts to get identify them. Subsequently the accused A1 was taken into police custody from Chanchalguda Jail, and was further interrogated thoroughly. During further investigation, the accused A1 gave the detail count of the involvement of the other accused persons, and basing on his information and in corroboration with the CCTV footages, the accused A3 to A5 were identified and apprehended on 13-12-2018, who too confessed their guilty in association with accused A1. At the instance of A4 Mohd Ayub one Cell phone was recovered.

The main conspirator A2 Mohd. Imtiyaz is found absconding and separate teams were deployed for his apprehension.

The arrested accused persons A3 to A5 were produced before the court and were remanded to judicial custody.

The Inspector of Police, PS Mir Chowk and SI Ramu, and team, under the supervision of the ACP Mirchouk, has work hard by using the latert technologies, and got identified and traced out the accused involved in the offence, are appreciated.
