NOTIFICATION

In exercise of the powers conferred upon me under section 21 (1) (b) of the Hyderabad City Police Act, I, ANJANI KUMAR, I.P.S, Commissioner of Police, Hyderabad City do hereby notify, for information of the general public that in order to facilitate proper regulation of traffic and ensure public safety in connection with the Construction of White Topping (Cement Concrete Road) SR Nagar Police Station 'T' Junction towards Balkampet Temple Junction. The following traffic restrictions and diversions will be imposed for a period of (16) day's w.e.f. 16-12-2018 to 31-12-2018.

∴ TRAFFIC DIVERSION ∴

1. Traffic coming from Satyam Theatre to Fateh Nagar will not be allowed towards Fatehnagar at SR Nagar PS 'T' Junction and it will be diverted towards SR Nagar Community Hall (Right Turn) – Abilash Towers – A.P. Cars – Bhogha Residency (Right Turn) – Holy Cross (Left Turn) – Fatenagar Road.
2. Traffic coming from Fatehnagar towards Satyam Theatre will be allowed as usual.
3. All by-lines and link roads from SR Nagar Police Station 'T' Junction towards Fatehnagar (Left Side Roads) will be closed.

All citizens are requested to take alternate routes and avoid the above routes and co-operate with the Traffic Police during the period of traffic diversion.

PRESS NOTE

Hyderabad Traffic Police is continuing its drive against the drunken drivers to ensure road safety. In the Month of **December-2018 (Upto 15th Dec)** caught **(961)** drivers who were driving the vehicle in drunken condition. Charge sheets were filed against them and were produced in the Hon'ble **3rd and 4th** Metropolitan Magistrate Courts, Nampally, Hyderabad. In this regard **3rd and 4th** Metropolitan Magistrate Courts awarded imprisonment to the **(265)** respondents and Permanently Cancelled / Suspended Driving licenses of **(58)** Persons for a period as mentioned below. The Hon'ble Courts imposed fine amount of Rs. **20,89,400/-** on the remaining **(903)** Traffic violators. All the candidates sentenced for imprisonment were sent to Chanchalguda Jail.

ONE SNATCHERS HELD – SEIZED ABOUT 16 ½ TOLAS GOLD ORNAMENTS, ONE MOTOR CYCLE, ONE HELMET AND ONE MOBILE PHONE.

On 15-12-2018, on credible information the Commissioner's Task force, **Central Zone Team**, Hyderabad, apprehended One Notorious Chain Snatcher who **committed (06) cases of Chain snatchings** in Hyderabad and Rachakonda Commissionerates and recovered Gold ornaments wg. about **16 ½ Tolas along with 1 motor cycle, 1 cell phone, 1 Helmet and 1 Black Colour marker Pen** used in the commission of offence.

Details of arrested person:

Kona Narsing Rao S/o K. Krishna, age 34 years, Occ: Driver, R/o H.No. 18-1-101/3/173/188, Shivasai Nagar, Uppuguda, Hyderabad.

Property Recovered:

Gold Ornaments weighing about 16 ½ Tolas, one Bajaj Discover motor cycle bearing Reg No. AP28BP4232, one black colour Helmet, one Black colour marker pen and one Cell phone **Total worth of Rs. 7,00,000/-**.

Modus Operandi:

The accused Kona Narsing Rao @ Narsing @ Narsimha is native of Hyderabad. He is a trained Boxer and participated in many State level competitions. In the year 2006 he discontinued his studies due to his family financial status. He took the responsibilities of his family after his father retirement. He performed various odd jobs for his family livelihood. He also worked as a part time Boxing coach @, Gowlipura ground. He took OLA CABS & UBER CABS for lease by paying deposit amount, for which he took heavy hand loans from known persons. The earnings were not sufficient and he went in to financial crisis and unable to return the loan amounts.

As such the accused started Chain Snatchings to get easy money. The accused is a single offender, wears helmet using his bike with False/Changed Number plate by editing with black marker pen to divert the Police, in commission of snatching offences. He commits snatchings in the odd hours with selected ladies mostly old aged who are going by walk, in lanes and by lanes in an isolated place. He targets the victims from

going behind on bike and come in an opposite direction while committing the offences. Before committing the offence, he moves all over the locality and select the escape routes so that he can easily escape from the offence place without any confusion. The offender rides the bike in very high speed and slow the bike near the victim and swiftly snatches the gold ornaments/ Mangalasutras from the neck of victims and escape from the scene in high speed in lanes and by lanes and avoid main roads to avoiding signals & CC Cameras. After committing the offence, the accused change the No. Plate and keep Original number plate and move in his locality with his original number plate, so that Police cannot find out the vehicle from the No. plate. In this manner he had committed so far 10 offences of Chain snatchings for the last 7 months in the limits of Gandhi Nagar and Amberpet Police stations of **Hyderabad Commissionerate** and Saroornagar, Uppal, Meerpet, Vanasthalipuram Police stations of **Rachakonda Commissionerate** by using the same bike with wrong number plate among them 06 cases were registered and 04 incidents the accused made an attempt as such no compliant was registered. The 06 cases are mentioned below

1. Crime No. 466/2018 U/s. 392 IPC of Meerpet PS
2. Crime No. 294/2018 U/s. 392 IPC of Amberpet PS
3. Crime No. 806/2018 U/s. 392 IPC of Uppal PS
4. Crime No. 806/2018 U/s. 392 IPC of Vanasthalipuram PS
5. Crime No. 303/2018 U/s. 392 IPC of Gandhinagar PS
6. Crime No. 842/2018 U/s. 393 IPC of Saroornagar PS

He pledge the stolen property at Muthoot and Manappuram Finance Ltd. and get the Gold Loans and spend that money lavishly. Police recovered the stolen property from the accused.

On a credible information the Commissioner's Task Force, Central Zone Team, Hyderabad, apprehended the accused and recovered **gold ornaments weighing about 16 ½ tolas**, One Motor cycle, One Helmet which was used for committing the offence, black colour marker pen which was used to change the Reg. No. of the vehicle and One Cell Phone from his possession.

The apprehended accused along with seized property were handed over to SHO, Gandhinagar PS for further investigation.

Action Plan:

Offenders involving repeatedly in chain snatchings would be proposed for detaining under PD Act apart from regular legal course of action as their acts creating panic in the minds of women folk in particular and public moving on roads in general and become prejudicial to the maintenance of the public order.
