### **SEX RACKET BUSTED – APPREHENDED ONE BROTHEL HOUSE ORGANIZER & TWO CUSTOMERS AND RESCUED ONE VICTIM**

On 15-12-2018, On credible information the sleuths of Commissioner's Task Force, West Zone Team, Hyderabad, raided on brothel house in the limits of Banjara Hills Police Station, Hyderabad and apprehended (3) persons and seized **net cash of Rs.2,190/-, (4) Cell phones, One Used Condom and One Unused condom** from their possession and also rescued (1) Victim.

#### **Details of accused persons:**

- 1.** Smt Shravani Kumari W/o Nageswhwar, aged 40 yrs, Occ: **Brothel House Organizer**, R/o H.No. 8-3-231/a/73/A, Krishna nagar, Yousufguda, Hyderabad
- 2.** M.Ramana S/o Sheshaiah, aged 31 yrs, Occ: Car driver, R/o Near Ganesh Temple, L.N Nagar, Yousufguda, Hyderabad, **(Customer)**
- 3.** Vijay Shankar S/o Srinivas Chary, aged 28 yrs, Occ: Car driver, R/o Beside Hanuman Temple, Mothinagar, S.R Nagar, Hyderabad, **(Customer)**

#### **Facts of the Case:-**

About six years back the accused Shravani Kumari came to Hyderabad for livelihood and worked in different places in Hyderabad. But his earnings are not sufficient to meet his lavish expenses. As such she hatched a plan to organize brothel house in Hyderabad.

About three months back she took the premises No. No.8-3-231/a/73/A, Krishna nagar, Yousufguda, Hyderabad on rent for Rs.11,000/- per month and running the brothel house at the above said premises with female sex workers. She used to bring girls from different localities to Hyderabad on agreement for payment of Rs.30,000/- per 15 days and running brothel House with them. About two weeks back the accused brought one female sex worker from West Godavari Dist of Andhra Pradesh State and running the brothel house at the above said premises.

On credible information the West Zone Task Force team raided the above said premises and apprehended the accused persons Shravani Kumari, M.Ramana and Vijay Shankar and rescued (1) Victim.

The arrested accused persons along with seized property and rescued victim were handed over to SHO, Banjara Hills PS, for taking necessary action.
