#### **TRAFFIC ADVISORY**

Today i.e., on 20.12.2018 Sailesh Kumar Gujjar, Managing Director of Sri Rishab Chit Fund India, Pvt Ltd and Smt. Nandini, Director of Sri Rishab Chit Fund India, Pvt Ltd are arrested by CCS, DD, Hyd.

On 12-12-2018 at 1900 hours received a complaint Sri. M Santosh Kumar S/o Late Pandarinath, age 39 years, Occ; Pvt. Employee, r/o H.No: 20-3-943/A, Shah Gunj, Chowk, Hyderabad and registered a case in Cr.No. 196/2018 U/s 406,420 IPC & and Section 5 of Telangana State Protection of Depositors of Financial Establishment Act 1999 and investigated into.

Sailesh Kumar Gujjar along with his wife Smt. Nandini Gujjar have started Sri. Rishab Chit Fund, India Pvt Ltd, in the year 2009 and got registered collected money in the form of chit business and also collected fixed deposits from their known persons. Further they diverted the money in Casino business at Goa and other business and suffered huge losses. They did not return the money to the chit members and depositors even after expiry of maturity dates since 1 ½ years.

The total amount cheated by the accused is expected to be around 50 to 60 Crores and around 500 victims and caused wrongful loss to them and wrongful gain to the accused. The arrested accused being produced before the Hon'ble court.

The case is being investigated by Sri. N. Sanjeev Rao, Asst.Commissioner of Police, Div-B, CCS, DD, Hyderabad under the supervision of Sri G. Jogaiah, Addl. Dy. Commissioner of Police, EOW, CCS, DD, Hyderabad.
