**NOTIFICATION**

WHEREAS, vide Memorandum No. IV-24011/49/2015-Prov-I/3334100, dated 16-12-2016 from Ministry of Home Affairs, ISI Division / VIP Security, Government of India, New Delhi, it has been brought to my notice that the Terrorist / Antisocial elements may organize attacks through Para Gliders, Remote Controlled Drones, Remote Controlled Micro Light Aircraft etc., and that there is an increasing trend by event's organizers to use remote controlled drones for getting aerial views for live telecasts and photography of various events.

WHEREAS, above mentioned Memorandum prescribes that State / UT Police under various sections of State Police Acts will prohibit flying of such aerial platforms over the area bounded by a circle of (30) Km radius centered at State Capitals / Metro Cities and (5) Km around strategic VAs/VPs and give due publicity to inform the public at large that doing so shall be an offence under Section 287 and 336, of IPC. This shall duly publicized.

Inputs have been received by Intelligence agencies about the possibility of attacks by Terrorist/Antisocial elements by the use of Para-glanders, Remote Controlled Drones, Remote Controlled Micro-Light Aircraft, etc., and there is every likelihood of breach of peace and disturbance of Public tranquility and also there is grave danger to human life, health, safety and damage to public property on that account.

AND WHEREAS, it is necessary that reasonable checks are imposed on activities of such antisocial elements in the limits of Hyderabad City Police Commissionerate to prevent the attack through Remote Controlled Drones or through Para-Glanders or through Remotely Controlled Micro-Light Aircraft.

NOW THEREFORE, I, Anjani Kumar, IPS, Commissioner of Police and Executive Magistrate of Hyderabad City vide powers conferred upon me U/s 144 of the Criminal Procedure Code 1973 (Act II of 1974), **do hereby order that no flying activities of Remotely Controlled Drones or Para-Glanders or Remotely Controlled Micro-Light Aircraft be allowed over the area bounded by a circle of (30) Km radius centered at State Capitals / Metro Cities and (5) Km around strategic VAs/VPs in the Jurisdiction of Hyderabad City Police Commissionerate limits.**

Any person contravening this order shall be punishable under section 188, 287 and 336 of the Indian Penal Code, 1860.

This order shall remain in force for a period of (6 months) i.e., 05-05-2019 to 04-11-2019.

As the notice cannot be served individually to all concerned, the order is hereby passed ex-parte. It shall be published for the information of public, through press and by affixing copies on the Notice Boards of the Police Stations, Divisional ACsP, Zonal DCsP offices.

**CRICKET BETTING BUSTED – APPREHENDED TWO PERSONS &  
SEIZED (1) T.V, (4) CELL PHONES AND NET CASH OF  
RS.51,500/-**

On 01-05-2019 the sleuths of Commissioner's Task Force, West Zone Team, Hyderabad, generated actionable information after making sustained efforts and apprehended (2) cricket betting organizers by name 1) Mohd.Razi Siddiqui and 2) Kamal Kishore Varma, while they were accepting cricket betting at Flat No.4, Mohamud Gulshan Apartments, beside Masjid-e-Osmania, King koti, Hyderabad from the known and unknown punters directly and indirectly i.e., over cell phones. **Seized 1) Net cash of Rs.51,500/-, 2) One T.V., 3) One Setup box, 4) Two Remotes, 5) One Calculator, 6) One Tab, 7) One Wi-fi Router, 8) One Pen, 9) One Line Phone make Nokia and 10) 3 Cell Phones** from their possession.

**Details of the Accused:**

1. Mohd.Razi Siddiqui S/o Mohd.Gulam Dastagir, aged 54 yrs, Occ: Perfumes business, R/o Flat No.4, Mohamud Gulshan Apartments, beside Masjid-e-Osmania, King koti, Hyderabad.
2. Kamal Kishore Varma S/o Bhagwandas Varma, aged 32 yrs, Occ: Pvt. Job, R/o Huda Colony, Attapur, Hyderabad.

**Modus Operandi:-**

The accused Mohd.Razi Siddiqui is native of Hyderabad. He hatched a plan to organize Cricket betting and to collect the betting amounts directly and indirectly i.e. through cell phones from the punters in Hyderabad. From the past three months he is organizing Cricket betting. He is collecting and distributing the amounts of betting from nearly 15 to 20 punters in twin cities. The accused Kamal Kishore is working to accused Mohd.Razi Siddiqui. The accused Kamal Kishore Varma used to take the calls from the punters on phones and also write betting amounts in the registers. For which the accused Mohd.Razi Siddiqui is giving some amount as commission to the accused persons Kamal Kishore Varma.

On 01-05-2019, as per their plan, the accused persons are running Cricket betting in an organized manner in the premises of accused Mohd.Razi Siddiqui i.e. **Flat No.4, Mohamud Gulshan Apartments, beside Masjid-e-Osmania, King koti, Hyderabad** and accepting Cricket betting over cell phones by watching in T.V. on ongoing **IPL-2019 Cricket match in between Chennai Super Kings Vs Delhi Capitals teams playing at MA Chidambaram Stadium, Chennai on 01-05-2019** and seized the above said property from the possession of accused persons.

The apprehended accused persons along with seized property were handed over to the SHO, Narayanaguda PS, Hyderabad for further action vide Cr.No.118/2019 U/s 3 & 4 of TS Gaming Act-1974 of Narayanaguda PS, Hyderabad City.

The raid was conducted under the supervision of **Sri P.Radha Kishan Rao**, Dy.Commissioner of Police, Commissioner's Task Force, by **Sri B.Gattu Mallu**, Inspector of Police, West Zone Team with the assistance of SIs Sri P.Mallikarjun, Sri L.Bhaskar Reddy, Sri B.Durga Rao, Sri Md.Mujaffar Ali and the staff of West Zone Team, Commissioner's Task Force, Hyderabad.
