

**PD ACT INVOKED AGAINST NENAVATH VINOD KUMAR @ AKHILESH KUMAR
S/O BICHA NAIK, BURGLAR, REINBAZAR POLICE STATION, SOUTH ZONE,
HYDERABAD**

Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City issued preventive detention order under Act No.1 of 1986 against Nenavath Vinod Kumar @ Akhilesh Kumar s/o Bicha Naik, Burglar of Reinbazar Police Station on 27.7.2019.

Nenavath Vinod Kumar @ Akhilesh Kumar s/o Bicha Naik, aged about 25 years, Occ: Car Driver, r/o H.No.8-75, Plot C-90, Balaji Nagar, Mallapur (v), Balapur (m), Ranga Reddy District, n/o Nichugutta Thanda (v&p), Amangal (m), Ranga Reddy District earlier involved in several offences in the limits of Hyderabad Police Commissionerate and detained under PD Act by Hyderabad Police Commissionerate in 2015. After his release from preventive detention he did not mend his attitude and committed 9 more offences. He was again detained under the PD Act by Rachakonda Police Commissionerate in 2017. He was released from jail after completion of 12 months in preventive detention.

After his release from preventive detention, he did not change his attitude of habitually committing offences and committed 14 more offences in the limits of Hyderabad and Rachakonda Police Commissionerates and he has been creating large scale fear and panic among the general public, thereby adversely affecting the public order, apart from disturbing the peace, tranquillity and social harmony in the society.

Reinbazar Police arrested the accused Nenavath Vinod Kumar @ Akhilesh Kumar on 10.5.2019 in Cr.No.30/2019 U/s 454, 380 IPC of Reinbazar Police Station and he was remanded to judicial custody. The Preventive Detention Order was executed on him on 28.7.2019 and he was lodged in Central Prison, Chanchalguda, Hyderabad.

**FAKE EDUCATIONAL CERTIFICATE RACKET BUSTED- 06 HELD
SEIZED HUGE FAKE EDUCATIONAL CERTIFICATES OF VARIOUS UNIVERSITIES.**

On 02-08-2019 the sleuths of Commissioner's Task Force, North Zone team busted bogus educational Academy styled as "Charminar College" and apprehended (06) accused persons. Wherein the prime accused Hasmatullah, is illegally running bogus educational Academy on the name of Charminar college, situated at # 23-1-1078/A, Opp. Bus stand, Charminar, Hyderabad (in the limits of Moghalpura PS) and providing fake & fabricated educational certificates of other state Universities to needy candidates by name 1)Syed Adnan Arif, 2)Abdullah M Saleem, 3)Mansurabad Sandeep,4) Mohd Shah Akram Ali, 5)Mohd Kaleemuddin and collected huge amount from them and gain illegal easy money.

Details of accused persons:

1. Hasmatullah S/o Qutubuddin, age. 37 yrs, Occ. Charminar College Director situated # 23-1-1078, Opp. Bus stand, Charminar R/o., RN Reddy Nagar, Meerpet N/o. Jajapur (Village), Narayanpet, Mahahabob Nagar (Prime accused & supply of fake educational certificates)

6. Mohd Kaleemuddin S/o. Mohd Moizuddin, age. 28 yrs, Occ. Pvt job R/o. Golconda, Hyderabad, (He purchased BBA certificates)

Brief facts of the accused

The accused Hasmatullah S/o Qutubuddin, age. 37 yrs is native of Jajapur (Village), Narayanpeth, Mahahaboob Nagar, Telangana State. His parents settled in Hyderabad and presently residing at RN Reddy Nagar, Meerpet. He completed his schooling and Intermediate & Degree in Open college. After completing degree he joined as faculty member in his relative's Sadana Vocational Jr.college, at Ram Nagar, Hyderabad. After gaining knowledge in the above field, he got in touch with management of Distance Universities of other States. From 2009 to 2014 he run Vocational Jr.College on the name of SCOPE Vocational Jr. College, at Himayath Nagar. After that From 2015 he is running bogus Distance college on the name of Charminar College at Charminar, Hyderabad. He used to supply fake & Fabricated educational certificates of other state universities to needy candidates. Previously (2) times he was arrested in Fake educational certificate cases.

Modus Operandi

Due to financial problems to gain illegal easy money hatched a plan to run Distance College and indulge in illegal delivery the fake & fabricated educational certificates to known and needy

candidates and he came into contacts with fake & fabricated educational certificates supply agents by name 1))Aijaz R/o. Gulbargha, (he is supply of fake educational certificates of Bangalore university)
2) Sandeep , Manager of Algot Business Studies, C/o. Delhi, (he is supply of fake educational certificates of Kalinga University)

Accordingly in the year 2015 he started a bogus distance college on the name of Charminar college situated at H.No. 23-1-1078, Opp. Bus stand , Charminar, Hyderabad (in the limits of Moghalpura PS) and used to publish adds in Siasath news paper and also distributing the pamphlets on the name of Charminar Educational Academy/Charminar College and informing to innocent students/ parents that in one sitting exams he will arrange BA/BCom/B.Tec/M.Tech, educational certificates of Distance Universities of Telangana state i.e Kakatiya University, Waranga Telangana Open School, Hyderabad, and Geetham University, Vishakaptnam, AP State, as well as Other state universities i.e 1)**Kalinga University**, Chhattisgarh, 2)**Benguluru University**, Gulbargha, Karnataka State, 3)**NIMS University**, Jaipur, Rajasthan state,

With glib talk he is trap the innocent students to join in his Charminar educational college and made them to believe that, he can provide original certificates from the above universities and giving offers to join in his Charminar Educational Academy. He used to college Rs. 50,000/- to 1,00,000/- depend on course from the candidate and provide fake & fabricates educational certificates of B.Com, M.Com, MA, B.Tech, BBA, B.Sc of 1)**Kalinga University**, Chhattisgarh, 2)**Benguluru University**, Gulbargha, Karnataka State, 3)**NIMS University**, Jaipur, Rajasthan state.

The accused Hasmatullah used to collect the data of the students who needs Educational certificates and he used to send the data of students to his agents 1))Aijaz R/o. Gulbargha, 2) Sandeep , Manager of Algot Business Studies, C/o. Delhi and after preparation of certificates the accused Hasmatullah will receive the fake certificates through courier services or directly and deliver the same to needy students by charging of Rs.1,50,000/- for Engineering certificates, Rs.50,000/- for Degree certificates, Rs.30,000/- for Diploma certificates.

Today the accused Hasmatullah while delivery the fake & Fabricated educational certificates at his Charminar College, Opp. Bus stand, Charminar, Hyderabad to the candidates 1)Syed Adnan Arif, 2)Abdullah M Saleem 3)Mansurabad Sandeep, 4)Mohd Shah Akram Ali, 5)Mohd Kaleemuddin on credible information the Task Force North Zone Team apprehended them along with Fake & Fabricated educational certificates.

The apprehended accused persons along with seized material handed over to SHO, Moghalpura PS for further investigation.

The apprehension was made under the supervision of **Sri. P.Radhakishan Rao, Dy.Commissioner of Police**, Commissioner's Task Force, Hyderabad by Sri K.Nageswar Rao, Inspector of Police, North Zone Task Force, and the SI Sri. B.Parameshwar, G.Rajashkar Reddy, K.Srikanth, & North Zone Task force Team, Hyderabad City.

If anyone tries to take the Law into their hands or resorts to any unlawful activities, a serious and swift legal action will be taken against them.
