

**GANG OF PREPARATION OF FAKE LAND DOCUMENTS & SELLING OF OLD NON-JUDICIAL STAMP PAPERS BUSTED – 02 HELD.**

On 03-08-2019, the sleuths of Commissioner's Task Force, East Zone Team, Hyderabad and apprehended 02-persons namely **1) Kranthi Suresh Kumar and 2) Mohd Ali**, who were indulged in preparation and selling of fake land registered documents of others, procuring and selling old and out dated Non-judicial stamp papers for wrongful gain.

3	<b>Satish</b> , aged about 40 yrs, R/o Old City, Hyderabad. <b>(Absconding)</b>

**Property seized:**

- 1) **228** - Old Non Judicial Stamp papers (blank & written)
- 2) **105** - New Non Judicial Stamp papers (blank & written)
- 3) **104** - Fake Rubber Seals & Stamps of Sub Registrars and various Govt. Officials.
- 4) One Stamp pad
- 5) Other incriminating material

**Brief facts of case:-**

On a tip off, today i.e., on 03-08-2019 in the evening hours, East Zone Task Force Team, Hyderabad, apprehended one Kranthi Suresh Kumar along with his associate Mohd Ali, who were indulging in preparation of fake land registered documents of others, procuring and selling old non-judicial stamp papers and seized incriminating material in huge quantity.

During interrogation, the accused confessed that they both are licensed stamp vendors at Secunderabad court and due to which they both came into contact. In this process they both hatched a plan to procure old Non Judicial Stamp Papers and sell the same to the known and needy customers. Subsequently Kranthi Suresh Kumar started procuring old Non Judicial stamp papers from one person by name Satish, aged about 40 yrs, R/o Old City, Hyderabad and handed over the same to Mohd Ali, who in turn sells it to the litigants/Real estate brokers and cheating the genuine authorized property owners.

The accused persons along with seized property were handed over to SHO, Gandhi Nagar PS, for taking necessary action.

The arrests were made by Sri **K.Srinivas**, Inspector of Police, East Zone Task Force, with the assistance of SI's Sri C.Venkatesh, P.Ramesh, G.Srinivas Reddy, Govindu Swamy and the staff of Commissioner's Task Force, East Zone Team, Hyderabad.
