DIVERTING ATTENTION – 02-HELD

The Commissioner's Task force, East Zone Team, Hyderabad, apprehended a **Diverting Attention gang** with the following members who have committed 04-offences of Diverting Attention in various Police Stations of **Hyderabad City and Nizamabad Dist** and **recovered Rs.1,60,000/-, One Bike, 05-Cell phones and other incriminating material** from their possession.

MODUS OPERANDI: -

Mohammed Sameeruddin @ Sameer @ Ajju and **Abdul Rizwan** both hail from Nizamabad District. The gang operates with two persons in which one person approach various money transfer agencies and Travels who are able to exchange Dirhams for Indian currency and other person will be waiting outside on the bike to flee away. In this process the accused approach the victim, with a black color pouch containing original Dirhams on the pretext of exchanging them with the Indian currency and hand over the pouch to the victim to count the Dirhams. After counting the Dirhams Victim calculate its value and quote the amount to accused, on which accused denies with the amount quoted by the victim and collects back the pouch from victim. Later by diverting the attention of victim accused exchange it with other pouch containing colour xerox copies of Dirhams and request to pay the amount quoted by the victim. As the victim hand over the Indian currency to the accused he collect the Indian currency and hand over the pouch containing xerox copies of Dirhams to victim and escape from the spot.

Earlier the accused **Mohammed Sameeruddin @ Sameer @ Ajju** was involved in Robbery case in the limits of PS Biknoor, Extortion case in the limits of PS Abids and rape case in the limits of PS Mailardevpally.

On the tip off the Commissioner's Task Force, East Zone Team, Hyderabad, police apprehended the accused and **recovered Rs.1,60,000/-, One Bike, 05-Cell phones and other incriminating material**, from their possession.
