

**TWO ABSCONDING ACCUSED & ONE RECEIVER HELD INVOLVED IN  
DACOITY & KIDNAPING – RECOVERED, (05) CELL PHONES AND NET CASH  
OF RS.50,48,000/-**

On 12-08-2019, the sleuths of Commissioner's Task Force, Central Zone team along with Chikkadpally PS Staff on credible information apprehended 2 absconding accused & 1 receiver who are involved in Dacoity & Kidnaping case pertaining to Cr. No. 252/2019 U/s 395, 364 (A) IPC of Chikkadpally PS.

**BRIEF FACTS:**

The accused Mirza Omer Ali Baig @ Baig Shab & Syed Salman were absconding from the date of commission of the crime, who are involved in Dacoity and Kidnaping of one person by name Gajender Parekh the owner of Maina Finance Company, Domalguda abducted on 28<sup>th</sup> July 2019 at about 11.30 pm. On 30-07-2019 the Commissioner's Task Force, Central Zone team detected and apprehended 03 accused out of 05 were handed over to SHO Chikkadpally PS. The rest of the 02 accused namely Mirza Omer Ali Baig @ Baig Shab and Syed Salman were absconding since then.

On 12-08-2019 the Commissioner's Task Force, Central Zone team on credible information apprehended the absconding 02 accused by name Mirza Omer Ali Baig @ Baig Shab, Syed Salman & Mirza Azhar Ali Baig (Receiver) and recovered the above property from their possession. All the 03 accused persons along with the recovered property were handing over to SHO Chikkadpally PS for further investigation in Cr. No. 252/2019 U/s 395, 364 (A) IPC of Chikkadpally PS.

The arrest was made under the supervision of **Sri. P.
