TRAFFIC ADVISORY

It is to inform that in view of 73rd INDEPENDENCE DAY Celebrations on 15-08-2019, the Hon'ble Governor of Telangana State will be hosting a reception (AT HOME) at Raj Bhavan, Hyderabad at 1730 hrs. A large number of dignitaries and guests are expected to attend the programme. Their vehicles will be parked at earmarked parking places in the vicinity of the Raj Bhavan and there is likelihood of traffic congestion on the following routes:

From Rajiv Gandhi Statue, Somajiguda to Khairtabad Junction i.e., on Raj Bhavan road both sides.

In view of the above, the commuters using Raj Bhavan road are advised to take alternate routes in order to avoid inconvenience from 1630 hours to 2000 hours.

Following is the parking arrangement for guests attending function at Raj Bhavan

1. All VVIPs including Hon'ble CM of Telangana State, Hon'ble Deputy CM of Telangana State, Chief Justice of Telangana State High Court, Hon'ble Chairman of Telangana State Legislative Council, Hon'ble Speaker of Telangana State Legislative Assembly, Hon'ble Central Minister and Hon'ble Ministers of Telangana State will enter through Gate-I and exit through Gate-II. Their vehicles have to be parked at the earmarked parking lot inside Raj Bhavan.
2. All other guests who are holding pink car passes will enter through gate 3, park their vehicles at parking lots inside Raj Bhavan and exit through the same gate.
3. Guests who are holding white car passes are requested to alight at Gate-III entrance and park their vehicles in the parking places at the following parking places:
 1. Parking at MMTS Parking lot.
 2. Parking at Park Hotel near MMTS.
 3. Single lane parking from Metro Residency to NASR School.
 4. Single lane parking from Lake View to V.V Statue Junction Opposite lane of Lake View Guest House.

All guests are advised to co-operate with traffic police in parking their vehicles in the above parking slots designated for them.

UNRAVELLED TEN YEAR OLD MURDER MYSTERY

On credible information, the **Commissioner's Task Force, South Zone Team, Hyderabad** with the assistance of RGIA Shamshabad Police of Cyberabad Commissionerate today i.e; on 14.08.2019 **unravelled the mystery behind (10) year old undetected murder case** and apprehended two accused persons who committed this murder.

PARTICULARS OF THE DECEASED:-

Sk. Basha S/o Peera, age: 25 years (2009), R/o Parsigutta, Secunderabad; N/o Sridevi Colony, Kadapa

The deceased is a native of Kadapa. He ran away from his house when he was about 10 years old and came to Hyderabad. Initially he sold Tea by moving on the streets in Parsigutta locality. Later he developed bad friend circle and got habituated to bad vices. To cope up with his expenditure he committed several house burglaries under the P.S limits of Chilakalaguda, Chikkadpally of **Hyderabad**; Narsingi, Balanagar, Rajendranagar of **Cyberabad** and Saroornagar, Uppal of **Rachakonda Commissionerate**.

During this period he got acquainted with **Palnati Seenu** of Parsigutta. Through Palnati Seenu he came in contact with **Allam Suresh and Waseem**. **Palnati Seenu** assisted the deceased Basha in disposing the stolen property and also in getting him out on bail whenever he was arrested.

NAMES & ADDRESS PARTICULARS OF ACCUSED PERSONS:-

1. **Allam Suresh** S/o Pentaiah, age: 33 years, Occ: Scrap Business, R/o Doodhbowli, Hussainialam, Hyderabad.
2. **Mohd. Waseem** S/o Mohd. Hameed, age:31 years, Occ: Driver, R/o Bandlaguda, Bahadurpura
3. **Palnati Srinivas @ Seenu** S/o Balaiah, age: 43 years, R/o Parsigutta, Secunderabad (**ABSCONDING**)

Palnati Seenu is involved in **(4) murder cases** under the limits of Saidabad of **Hyderabad**; Dundigal, Balanagar, of **Cyberabad** and Kushaiguda of **Rachakonda**. In the year **1998**, he murdered one Govind Raj, Rowdy Sheeter of Balanagar P.S. In the **same year**, he took Supari from one Krishna Reddy and killed Narender Reddy under the

limits of Saidabad P.S. In the year **2003**, he took Supari from one Riyaz (Ex-Rowdy Sheeter of Gandhinagar P.S) and killed Nakka Mohan (Ex-Naxal) of Warangal under the limits of Kushaiguda P.S. In the year **2005**, he killed one Ashok Chary of Bollaram under the limits of Dundigal P.S. He was arrested under **Arms Act** by Musheerabad, Bowenpally police of **Hyderabad** and Uppal police of **Rachakonda**.

Allam Suresh, a native of Doodhbowli is presently doing Scrap business. He is married in the year 2014 and blessed with a son. At the instance of Palnati Srinivas, he along with Palnati Rakesh (Brother of Palnati Srinivas) committed **(14) House burglaries** under the limits of KPHB, Madhapur, Jeedimetla, Petbasheerabad, Balanagar, Alwal of **Cyberabad**; Meerpet of **Rachakonda Commissionerate**. He is also involved in **automobile theft** case under the limits of Mirchowk and Hussainialam P.Ss. He was also arrested under **Arms Act** along with Palnati Srinivas at Musheerabad P.S. and Bowenpally P.S.

Mohd. Waseem, a native of Bahadurpura is a driver by profession. He is married about (9) years ago and blessed with three children. He is involved in a Murder case in the year 2016 under Bahadurpura P.S limits and a Robbery case under Afzalgunj P.S limits and in **(1) automobile theft** case of Kamatipura P.S.

Relation between accused:

The accused **Allam Suresh** came in contact with **Palnati Srinivas** at Chanchalguda Jail in the year 2001, when he was arrested by Mirchowk P.S. Allam Suresh introduced Waseem to Palnati Seenu. By that time, Palnati Srinivas was involved in several hired (supari) killings. He was also involved in several illegal activities like land grabbing and threatening the opponents. As such in no time he developed enmity with many and anticipated threat to his life from opponents. So, whenever, Palnati Seenu went to Court for attendance, Allam Suresh and Waseem along with others followed him for protection and keep watch over his opponents.

MOTIVE:-

Palnati Seenu, was disposing the stolen property whenever deceased Basha committed offences. As time passed by, differences arose between the two over the sharing of stolen property. Palnati Seenu bore grudge against Basha for disposing the stolen property through one lady (concubine of Basha) instead of him and also for having illegal contacts with his girlfriend and misleading her. He also felt that after deceased got acquainted with his girlfriend, she began avoiding him. So he decided to eliminate deceased Basha.

EXECUTION:-

Palnati Seenu instructed Allam Suresh and Waseem to kill the deceased Sk. Basha and offered each of them **Rs.2 lakhs**. On the instructions of Palnati Seenu, on 09.05.09 at about 8 P.M, Allam Suresh picked up deceased at Parsigutta on the pretext of consuming liquor and celebrating a party. Both travelled towards Bahadurpura on the motorcycle. On the way Allam Suresh contacted the other accused Waseem. Waseem joined them at Bahadurpura X Roads. Later three left on the same motorcycle towards Aramgarh. At Aramgarh, the three consumed liquor at a Bar & Restaurant. The deceased was made to drink heavily in the Bar till he lost his consciousness. From there, all the three left towards Shamshabad. They also carried with them some more liquor. At Shamshabad they took the road towards Rallaguda village. After travelling 1 km from Shamshabad RTC Bus Stand on the above road, they took a small road adjacent to ORR. After travelling about 100m, the accused took the deceased to an isolated place and again forced him to consume liquor. Later Suresh pulled down the deceased by tightening rope around the neck. When the deceased fell down, the other accused Waseem hit him over the face with a granite stone. After confirming that the deceased had died, both the accused removed the shirt and pant of deceased and poured petrol over his face and burnt the face of deceased as per the directions of Palnati Seenu. They did so to conceal/hide the identity of deceased. On the return, they threw the dress of the deceased in the bushes adjoining Hyderabad-Bengaluru Highway. After that they intimated the same to Palnati Seenu, but he did not believe them. To confirm the death of the deceased, Palnati Seenu accompanied Allam Suresh and Waseem to the spot in the early hours of 10.05.09. Palnati Seenu got confirmed and satisfied after seeing the dead body of Basha.

The death of **Sk. Basha** was reported as death of an unidentified person and a case vide. **Cr.No: 238/09** U/s 302, 201 IPC was registered at RGIA Shamshabad P.S of Cyberabad Commissionerate on 10.05.2009 and investigated into. Later, the case was referred as **Undetected**, as the identity of the deceased and accused persons was not known.

How the case was detected and identity of deceased established:

On a reliable information, the above accused persons were picked by the sleuths of South Zone Task Force and interrogated with the assistance of RGIA Shamshabad Police of Cyberabad Commissionerate. The accused confessed of killing the deceased and identified the location of crime scene. The identity of deceased, facts and crime

scene got matched to the unknown dead body of above mentioned case of RGIA Shamshabad P.S.

Motto of Hyderabad City Police:

No criminal can go scot free once he commits crime irrespective of time period.
