NABBED ONE NOTORIOUS SNATCHING OFFENDER

Detected (3) cases i.e Robbery & Snatching cases of Bowenpally-01, Malakpet-01 & Kukatpally PS-01

On Credible information the sleuths of Commissioner's Task Force, North Zone team in joint operation with Police Bowenpally PS laid a trap near Old Airport road, Bowenpally, intercepted one Car Reg no.TS10UA9774(Tata Indica), found a notorious Snatching offender Mohd.Faisal S/o. Mohd Ayub, age.25 yrs with the possession of dagger. Previously twice invoked PD Act against him. Detected (3) Cases i.e Bowenapally PS-01, Malakpet PS-01, Kukatpally(Cyberabad) PS-01.

➤ **DETAILS OF ACCUSED :-**

Mohd.Faisal S/o Mohd.Ayub, aged about 25 years, Occ: Auto driver, R/o Hassan Nagar,Rajendra Nagar, R.R. District N/o. Barkas, Chandrayangutta, Hyderabad(Snatching offender).

➤ **SEIZED MATERIAL :**

1. One dagger (**Cr.No.296/2019**,U/Sec.25(1B)(b) of the Indian Arms Act -1959 of Bowenpally PS)
2. One mobile phone model Oppo (pertains to **Cr.No.249/2019** of Bowempally PS)
3. One mobile phone model Realme (pertains to **Cr.No.217/2019** of Malakpet PS)
4. One mobile phone model Poco (pertains to **Cr.No.495/19** of Kukatpally PS),
5. One mobile phone model Oppo (Belongs to Accused)
6. Two motor cycles (Used in commission of offence-Reg No.TS09CL TR8622 Pulsar 220 CC & TS12EE5876 , Bajaj pulsar 150 CC)
7. One car Reg no. TS10UA9774 (Tata Indica)

➤ **MODUS OPERANDI:-**

The accused Mohd.Faisal is a notorious habitual snatching offender and maintaining a gang. To gain easy money illegal way by snatching costly Cell Phone, cash bag etc , in the night hours he along with his associate are moving on the high speed Bajaj pulsar vehicles, on the way in isolated areas target the lonely victim who is going by walk, slow down the vehicle near the victim, immediately snatching Cell phones, cash bag from the hands of victim and left from the spot in high speed along with the stolen property.

BRIEF FACTS OF FIR CASES:-

1. Cr.No.249/2019, U/Sec. 392 IPC of Bowenpally PS

On 12-7-19 at about 23.10 hrs the accused Mohd Faisal & associate Abood Bin Haji Ballasgha moving on pulsar vehicle 150 CC Reg no. TS12EE5876 near Jay Yogeswar Timber & Plywood shop, Bowenpally targeted the complainant/Victim A.Suman Kalyan, age. 30 yrs, reached him and robbed his mobile model OPPO A11 and fled way with high speed on their vehicle.

2. Cr.No.217/2019, U/Sec. 382 IPC of Malakpet PS

On 10-08-2019 at 01.00 am the accused Mohd Faisal moving on Bajaj pulsar 220 CC Reg no. TS09CLTR 8622, on the way near Vaibhav Jewellers, Dilsukh Nagar, Malakpet PS limits targeted the complainant/victim Nagendra Kumar T, age. 26 yrs, reached him and snatched his mobile phone model Oppo real me2 Pro and fled away on the vehicle.

3. Cr.No.495/2019, U/Sec.382 IPC of Kukatpally PS, Cyberabad

On 10-08-2019 at about 2315 hrs the accused Mohd Faisal & Associate Abood Bin Haji Ballasgha moving on pulsar vehicle 220 CC Reg no. Reg no. TS09CLTR 8622 on the way near AC Bus stop, KPHB, the accused persons targeted the complainant/Victim Syed Abdul Azeem, age. 30 yrs, reached him and snatched his mobile model Poco F1 Mi and fled way with high speed on their vehicle.

➤ BRIEF HISTORY OF ACCUSED:

The accused Mohd.Faisal, S/o Mohd.Ayub, aged about 25 Yrs is residing at Hassan Nagar, Rajendra Nagar, R.R. District. He studied upto 7th class. He used to consume liquor, Ganja and having bad vices, moving with criminals and maintaining criminal gang. He is a notorious habitual snatching offender. He committing snatching Cell phone, cash bag, Robbery, HB by night etc & involved in a Murder case of deceased Waleed.

The accused having criminal record since 2013. So far he involved in **(18)cases** i.e Snatching cases-**14**, Ordinary theft-**01**, H.B by night(attempt)-**01**, Murder case-**01** & Robbery-**01**.

Due to criminal history twice invoked **PD Act** against him i.e 2015 & 2017 and lodged in Central prison Chanchalguda.

After released from PD Act he did not change his attitude, attempted H.B by night in the limits of Rajender Nagar PS, Murder case in the limits of Chandrayan gutta PS and arrested and remanded to judicial custody.

Recently the accused Mohd Faisal along with his associate Abood Bin Haji Ballasgha (absconding) have committed (3) Robbery/Cell phone snatching offence vide **1)Cr.No.249/2019, U/Sec. 392 IPC of Bowenpally PS,**

2)Cr.No.217/2019, U/Sec. 382 IPC of Malakpet PS & 3) Cr.No.495/2019, U/Sec.382 IPC of Kukatpally PS, Cyberabad. While illegal procured & possession of deadly weapon(dagger) registered case in 4)Cr.No.296/2019, U/Sec.25(1B)(b) of Indian Arms Act of Bowenpally PS.

➤ **ARREST:**

To detect the robbery case of Bowenpally PS verified the CCTV footages at possible places, got identified the footage of accused persons and Bajaj pulsar vehicle & with reliable sources on tip off the Commissioner's Task Force, North Zone team in joint operation with Police Bowenpally PS near Old Airport, Bowenpally intercepted a Car Reg no.TS10UA9774(Tata Indica), and apprehended the accused Mohd Faisal and found possession of a dragger with him illegally.

Seized One dagger, 04 Mobile phones, 02 Motor cycles, one Car from the instance of accused Mohd Faisal.

The accused person along with seized material handed over to SHO, Bowenpally PS for further investigation.

RAID ON GAMING HOUSE UNDER THE LIMITS OF CHIKKADAPALLY PS - (12) PERSONS HELD -SEIZED NET CASH Rs. 1,02,650/- (One Lakh Two Thousand Six Hundred and Fifty), (14) CELL PHONES & PLAYING CARDS

On 20-02-2019, night the sleuths of Commissioner's Task force, **Central Zone Team**, Hyderabad along with Chikkadapally police, on credible information conducted raid on common Gaming house situated at H.No.1-8-4/1/21/A, Waheeda Bagh, Chikkadpally, Hyderabad and apprehended (12) respondents and **Seized net cash 1,02,650/- (One Lakh Two Thousand Six Hundred Fifty), (14) Cell Phones, (156) Playing Cards & 2-Sealed Playing Cards Pack** from their possession.

BRIEF FACTS OF THE CASE:

The respondent Prakash Yathuai and Naveen Shetti is organizing Three cards game which is a game of chance at their residence which is located at H.No.1-8-4/1/21/A, Waheeda Bagh, Chikkadapally, Hyderabad since last three months and they are inviting known/un known punters and his friends to their rented House and playing three cards game on commission basis and gaining illegal money. He is charging Rs. 500/- per game as commission. As usual, on 20-08-2019 they all gathered in the above said premises and while they were playing three cards by betting money, on credible information Central Zone Task Force Team along with Chikkadapally Police conducted a raid on above said premises and apprehended the respondents.

In this case **Seized net cash 1,02,650/- (One Lakh Two Thousand Six Hundred Fifty), (14) Cell Phones, (156) Playing Cards & 2-Sealed Playing Cards Pack** from the possession of respondents. The above (12) respondents along with seized property were handed over to SHO, Chikkadapally Police Station for taking necessary action.
