**NOTIFICATION**

In exercise of the powers conferred upon me under section 21 (1) (b) of the Hyderabad City Police Act, I, **Anjani Kumar**, I.P.S., Commissioner of Police, Hyderabad, hereby notify, for information of the general public, that, in order to relieve congestion, to maintain smooth flow of traffic and to ensure public safety and order, in connection with **HYDERABAD RUNNERS MARATHON RUN**, the following restrictions and diversions will be **imposed from 0430 hours to 0900 hours on 25-08-2019**.

**TRAFFIC DIVERSIONS:**

1.	Traffic coming from <b>VV Statue</b> towards flyover and Necklace Rotary will be diverted at V.V statue towards <b>Shadan and Nirankari Bhavan</b> .
2.	Traffic coming from <b>Telugu Thalli</b> will be diverted at Helipad Lane towards Mint-Khairatabad (Bada Ganesh).
3.	Traffic coming from <b>Iqbal Minar</b> intending to go towards Upper tankbund will be diverted on Telugu Thalli flyover at Old gate Secretariat
4.	Traffic coming from <b>Liberty</b> intending to go towards Upper tank bund will be diverted at GHMC office towards BRKR Bhavan, Telugu Thalli, Iqbal Minar "U" Turn and on Telugu Thalli flyover.
5.	Traffic coming from <b>Karbala Maidan</b> towards Upper Tank bund will be diverted at Children's Park towards DBR Mills Road.
6.	Traffic coming from <b>Kawadiguda 'X' Roads</b> will not be allowed towards sailing club.
7.	Traffic coming from <b>DBR Mills</b> will not be allowed towards Children Park.
8.	Traffic is not allowed on Nallgutta beck side towards. Traffic from Ministers road will be diverted towards Ranigunj and traffic from Ranigunj will be diverted towards ministers' road at Nallagutta Junction.
9.	
10.	When the Marathon arrives at Necklace Rotary, the traffic coming from Begumpet towards Rajbhavan will be diverted <b>at Green lands</b> towards Ameerpet till the Marathon goes beyond K.B.R. Park Junction.
11.	When the Marathon enters Panjagutta flyover, the traffic coming from Panjagutta towards Road No.2, Banjara Hills will be diverted <b>at NFCL Island</b> towards Road No.1, Banjara Hills till the Marathon goes beyond

	KBR Park Junction.
12.	When the Marathon enters Sagar Society Jn., the traffic coming from Orissa Island / Road No.10, B/Hills will not be allowed towards NTR Bhavan. The traffic coming from Road No.10, B/Hills will be diverted <b>at Cancer Hospital</b> towards Orissa Island and the traffic coming from Orissa Island will be diverted at Cancer Hospital towards Road No.10, Banara Hills.
13.	When the Marathon run reaches Hyderabad Gymkhana Club, the traffic coming Film Nagar/ Road No.45 towards Jubilee Hills Check Post will be diverted <b>at Road No.1/45 Jn</b> towards Road No. 45 dead end.
14.	Traffic will not be allowed towards Road No.36, Jubilee Hills when the Marathon goes beyond Jubilee Hills Check Post towards Madhapur and the traffic coming from Venkatagiri 'T' Jn., KBR Park will be diverted <b>towards Road No.2, Banjara Hills.</b>
15.	When the Marathon reaches Ushakiran Jn., the U turn opposite L & O PS Jubilee Hills will be closed and traffic is allowed only towards Jubilee Hills check Post.

General public are requested to avoid above roads and take alternate routes to reach their destination and cooperate with the Traffic Police.

Eexecutive Engineer.

On the complaint of Sri Kotagiri Ramarao S/o. Veerananarayana, R/o. 3-6-425, Flat No 201, Legend Soma Apartment, Himayathnagar, St No .4 Hyderabad registered a case in Cr No 108/2019 U/s 406, 420IPC was registered at CCS, DD, Hyderabad and investigated by Sub-Inspector WCO Team-XII.

The accused **Tangeda Venkata Siva Naga Subrahmanya Vara Prasada Rao** is a practicing Advocate in High court of Telangana and A.P. he was arrested and produced before the Hon'ble Court for Judicial custody.

**APPREHENSION OF DIVERSION ATTENTION OFFENDERS AND RECOVERY OF**

**CASH OF Rs.12,00,000/-**

On **22-08-2019**, sleuths of Saidabad PS have apprehended three diverting attention offenders and recovered entire stolencash of **rs.12,00,000/-** from their possession with in **48 hours of the reporting of crime.**

**Details of accused:-**

**A1. Abed Mohiuddin @ Abed**, S/o. Ahmed Mohiuddin, age: 35 yrs, Occ: Business AM Metal Store, Opp Indian Oil Petrol Pump, Chandrayangutta, R/o. H.No.3-C/1/35/1, Nabeel Colony, Chandrayangutta, Bandlaguda, Hyderabad.

**A2: Shaik Abdul Basith @ Basith @ Basid**, S/o. Late Shaik Abdul Quader, age: 34 Years, Occ: Business Development Manager at Loinsgate Water bottle company, Jublee Hills, R/o. H.No.18-7-426/124, Chacha Garage Lane, Aman Nagar Bee, Talabkatta, Bhavani Nagar, Hyderabad.

**A3. Sambaram Rajesh @ Rajesh**, S/o. Yadagiri, age: 28 yrs, Occ: Petrol Pump employee at India Oil, Putlibowli, Koti, Hyderabad, R/o. H.No.1-10-31/1/A, Near Welkin Park, Prakash Nagar, Begumpet, Hyderabad. N/o. Kothawada, Warangal Dist. (Aadhar Address: H.No-3-6-132, Bhaksar Rao Garden, Nehru Nagar, West Marredpally, Hyderabad.

**MODUS OPERANDI.**

The accused **A1.A2** are common friends while A.3. was working in the patrol pump of victim / complainant Sri. Raj Kumar Bagadia. A.1 and A.2 are known to the victim since last few years and used to visit his petrol pump. Seeing the weakness of the complainant for making money through unfair means, A.1 to A.3 hatched a plan to lure the victim and commit theft of net cash under the promise of arranging him a particular series of banned old currency notes of the year 2002, so that he could get Rs.50000/- new currency for each note of that particular series of 2002 currency note.

According to their plan while A1 & A2 were present at complaint office situated at Sri Santhoshi Filling station (Indian Oil), Ranga Mahal Road, Putlibowli, Koti, Hyderabad, A3 introduced A1 and A2 to his employer and informed to the victim that one can get Rs. 50,000/- of new currency for each of Rs. 500/- old note of 2002 series and A.1 and A.2 can readily arrange a party to get particular series of old currency notes of the year 2002.

A.1 to A.3 could make the complainant to believe their version and complaint asked A1 & A2 to provide 2002 series notes to him. According to their plan on 17-08-2019, A1 informed the Complaint that he secured one party who had two crore of old demonetized currency notes

and the party is asking Rs. 12,00,000/- to buy two crore of old demonetized notes and asked the complainant to be ready with Rs 12 lakh by Sunday i.e 18-08-2019.

Accordingly the compliant arranged Rs.12 lakh net cash A2 joined with Complaint at his Sri Santhoshi filling station and brought him to Saidabad, SBH Colony Park . At about 11.00 am A1 came there on a motor cycle and met the complainant and A.2 and A.1 told the victim that the house of the party who had 2 crore old currency notes is close by and he will go to his house to show the net cash Rs.12 lakh to the party and then only the party will allow others to come his house. Saying so, A1 collected the bag containing Rs.12 lakh net cash and went away on the motor cycle asking the compliant and A.2 to wait till he returns. A1. A1 escaped with net cash. After some time the complaint started calling A1 but he did not respond. and absconded.

Later A1 contacted his associate A2 through new phone and on the next day A2 met A1 at his house and they shared the stolen amount. Out of Rs. 12,00,000/- A1 gave Rs. 5,00,000/- to A2 and the remaining amount of Rs. 7,00,000/- kept with A1.

After making some efforts to contact the absconding accused persons the complainant understood that he was cheated by the accused A.1 to A.3 and on 20-8-2019 he came to Saidabad Police station and lodged a complaint narrating the manner in which he was cheated by the accused by diverting his mind and theft of net cash 12 lakhs. Based on the complaint the Saidabad police registered a case in Cr No. 314/2019 u/s 379, 420 IPC and the crime team headed by D.I Sri. P.Suresh and DSI Sri. Madava Rao swung into action and on 22-8-2019 apprehend the accused persons A.1 to A.3 within 48 hours of reporting the crime and successfully recovered the entire stolen net cash Rs.12 lakhs from the possession of A.1 and A.2

On 15-08-2019 at about 03:00 hrs the accused A-1 Pottela Ramesh gained entry into the hut, near Jamai Osmania by keeping the A-2 to watch outside and committed theft and handed over one cell phone to A-2. After committing this offence, theA-1 Pottela Ramesh entered into the Girls Engineering Hostel, through a ventilator of the bathroom using an iron stool while the A-2 kepta watch outside. After committing theftA-1 handed over two mobile phones to A-2 as his share.

On 22-08-19, East Zone Task Forceapprehended the accused person A-2 at his home and recorded detailed confession, he stated that he and A-1 Pottela Ramesh committed theft of cell phones from the Girls Hostel, OU Campus and huts near the Jamai Osmania railway Station and recoveredthree mobile phones from his possession.

**The A-1 Pottela Ramesh is previously involved in Night HB cases and he was detained under PD Act from Meerpet police station, Rachakonda and the accused A-2 also was remanded in Illicit liquor cases from Musheerabad, Sultan Bazaarand Narayanguda Police stations and he was also detained under PD act from Narayanguda Excise PS.**
