SEIZURE OF 200-KGs OF GANJA - 02-PERSONS HELD

On 03-06-2019, the Commissioner's Task Force, East Zone Team, Hyderabad, apprehended 02 - persons namely 1) Shaik Arif and 2) Shaik Sameer who were in illegal possession of Narcotic Drug i.e., Ganja, Near GM Chowni, Near Beedi Karkhana, Chatrinaka, Hyderabad and **seized 200 Kgs of Ganja, One Maruthi Suzuki Swift Desire car Bearing No.AP28DQ9464 and one cell phone.**

Brief Facts:-

Acting on a tip off, the Commissioners Task Force, East Zone Team, Hyderabad, apprehended 02-persons who are in illegal possession of Narcotic Drug i.e., Ganja and seized 200-Kgs of Ganja and One white colour Maruthi Suzuki Swift Desire car Bearing No.AP28DQ9464, from their possession.

During interrogation the accused Shaik Arif confessed that he is a native of Nanded, Maharashtra and from past couple of years he is residing in Hyderabad by eking out his livelihood as a Roti maker. Since the income from Roti making is not sufficient to meet his family expenditures, he met his cousin by name Ashwaq, R/o Nanded, Maharashtra and discussed with him about his insufficient earnings. They both decided to earn easy money by procuring Ganja from agency area, transport and sell the same to the known and needy customers and earn huge profits. In this process Ashwaq along with Shaik Arif contacted one Srikanth of Vizag and requested him to provide Ganja, on which Srikanth agreed. Subsequently, Ashwaq and Shaik Arif contacted one Shaik Sameer, R/o Nanded, Maharashtra and discussed about transporting Ganja in a car and offered him to pay good commission. Accordingly two days back Shaik Arif and Ashwaq engaged one Maruthi Suzuki Swift Desire car B.No.AP28DQ946 to transport the contraband. Shaik Arif and Shaik Sameer went to agency area of Vizag and met Srikanth and procured Ganja of 200 kgs at Rs.1,500 per kg.

On 02-02-2019 both the accused persons after procuring Ganja left from agency area of Vizag in Maruthi Suzuki Swift Desire car B.No.AP28DQ9464 (White colour) and reached to Shaik Arif's residence at GM Chowni, Near Beedi Karkhana, Chatrinaka, Hyderabad and halted in the night and next day morning i.e., today on 03-06-2019, while they were about to leave from GM Chowni, Near Beedi Karkhana, Chatrinaka, Hyderabad to Nanded in Maruthi Suzuki Swift Desire car B.No.AP28DQ9464 (White colour) along with Ganja, the East Zone Task Force Team apprehended them along with the said car and Ganja.

In this case 02-accused persons namely 1) Ashwaq, R/o Nanded, Maharashtra and 2) Srikanth, R/o Vizag, A.P., are in absconding and efforts are being continued to apprehend them.

The above accused persons and seized property were handed over to SHO, Chatrinaka PS, for taking further action.

NABBED INTER STATE (WEST BENGAL) ROBBERY GANG - 02 HELD

DETECTED ROBBERY CASE OF TRIMULGHERRY PS.

The sleuths of Commissioner's Task Force, North Zone team nabbed **Inter State (West Bengal) ROBBERY Gang** of two accused persons, wherein the robbery gang have conspired together to commit robbery and entered into the house of complainant/Victim Bansi Karnakar N/o. West Bengal, presently staying single at Vasundhara Apartment, Trimulgherry, Secunderabad and the accused persons tied his mouth, hands from backside with a towel, searched the house, committed theft of one cell phone, Gold, Silver ornaments, some cash in the house and decamped with stolen property.

BRIEF FACTS OF THE CASE:-

Cr. No. 91/2019, U/Sec. 392 of PS. Trimulgherry PS.

On 26-05-2019 at about 1745 hrs while the complainant/victim Bansi Karnakar, R/o.: Flat No.124, Vasundhara Apartment, Saraswathi Nagar Colony, Trimulgherry, Secunderabad while staying single and watching TV, meantime the accused persons, entered into his house and tied hands from back side and mouth with the available towel, threatened him and went into hall and committed theft of MI Phone & broke open the Almirah stolen gold & silver ornaments and some cash, later bolted from outside and sped away with the booty.

MODUS OPERANDI:-

The accused Shaik Babu, age.24 yrs is native of West Bengal State. Presently residing at Khairane(village), Washi, Maharashtra State. He is doing as Construction labour for his livelihood. While doing labor work he acquaintance with a sex worker Sumi vinod Gupta N/o. West Bengal and living together. The said sex worker also came into close with the complainant Bansi Karnakar N/o. West Bengal State, used to meet him at his residence, Secunderabad.

The accused Shaik Baba having huge debts, facing financial problems to clear his debts and to spend lavish life he along with sex worker Sumi vinod Gupta have hatched a plan to gain easy money by commit theft of Gold, silver

& net cash from the house of Banshi Karnakar, situated at Vasundhara Apartment, Saraswathi Nagar Colony, Trimulgherry, Secunderabad where expected that having huge money and gold in the house.

The prime accused Shaik Baba explained robbery plan to his associate Aobid Yohid Mulla N/o. West Bengal, then he accepted to execute their plan.

As per the advise of Sumi vinod Gupta, the accused persons Shaik Baba and his associate Aobid Yohid Mulla came to Hyderabad by train to commit theft of Gold, silver ornaments, cash etc in the house of Banshi Karnakar.

EXECUTED ROBBERY PLAN:-

On 26-05-2019 evening hours with the assistance of Sumi vinod Gupta the accused persons reached near the house of victim/complainant at Vasundhara Apartment, Saraswathi Nagar Colony, Trimulgherry, Secunderabad and surveillance on the area, the said lady Sumi vinod Gupta shown the target house and found that the complainant Banshi Karnakar available single in the house and left from the place. At about 1745 hrs the accused persons Shaik Baba, Aobid Yohid Mulla entered in to the house of Complainant and bolted from inside, threatened him, forcibly closed his mouth, with the available towels tided his hands from back side & Mouth. The accused persons went to the hall and took his MI Phone, broke open the Almirah, committed theft of Gold, Silver ornaments and some cash, while they were leaving they brought the complainant to the bed room and bolted from outside and sped away with the stolen property.

ARREST:-

To detect the robbery case of Trimulgherry PS, verified the CCTV footages at possible places, got identified the footage of accused persons & with reliable sources today laid a trap and apprehended two accused persons 1) Shaik Babu, 2)Aobid Yohid Mulla.

Seized 03 mobile phones & Silver ornaments belongs to victims from the instances of above accused persons.

The accused person along with seized material were handed over to SHO, Trimulgherry PS for further investigation.
