**NOTIFICATION**

In exercise of the powers conferred upon me under section (21) (1) (b) of Hyderabad City Police Act, I, ANJANI KUMAR, IPS., Commissioner of Police, Hyderabad City, do hereby notify, for information of the general public, that, in order to facilitate proper regulation of traffic without causing inconvenience to the general public in connection with the "Distribution of Fish Prasadam" on Mrugashirakarti on 8<sup>th</sup> June, 2019 from 4.00 PM to 9<sup>th</sup> June, 2019 6.00 PM, at Exhibition Grounds, Nampally, the following diversions will be enforced:

1. People coming on 4-wheelers from Nampally side for Fish Prasadam should park their vehicles at Gruha Kalpa, Gagan Vihar & Chandra Vihar and proceed on foot towards Ajanta Gate/Gate No.2 Exhibition Ground for Fish Prasadam, whereas people coming on four wheelers from M.J.Market should park their vehicles at M.A.M. Girls Junior College, besides Board of Intermediate Education, Nampally.
2. The People coming for Fish Prasadam in buses / vans from M.J. Market should alight at Gandhi Bhavan Bus Stop. While the Buses / Vans coming from Nampally shall alight at Gruha Kalpa Bus Stop and proceed to Ajanta Gate/ Gate No.2 Exhibition Ground for Fish Prasadam on foot, after alighting they should park their vehicles at Goshamahar Police Stadium.
3. All VIP car pass holders coming from M.J. Market towards Gandhi Bhavan should take left turn towards Gate No. 1 of Exhibition Ground and CWC Gate towards VIP Entry Gate and the VIP car pass holders coming from the Nampally will take "U" turn at Gandhi Bhavan and take left turn towards Gate No. 1 and towards VIP Entry Gate i.e. CWC Gate. The VIP vehicles will be parked at VIP Parking area at CWC Godowns.
4. After taking the Prasadam, the VIP Cars will exit from VIP Gate, CWC Gate, Aadab Hotel and take left turn and proceeds towards Nampally.
5. People coming on 2-wheelers for fish Prasadam from M.J.Market shall park their vehicles at Manoranjan Complex parking area. The two wheelers coming from Nampally should park their vehicles at left side of the main road / earmarked for 2-wheelers In between Gruha Kalpa to BJP Office.

6. Auto alighting arranged for people coming for Fish Prasadam in front of Shezan Hotel, Bhavani Wines / Juvenile court and Excise Office. On the left side of the road, parking area for the autos are earmarked.
7. Government vehicles shall be parked at Bheem Rao Bada, Nampally, Hyderabad.
8. The General Traffic coming from the M.J. Market side, will be diverted towards Abids, GPO and Nampally Station Road on need basis.
9. The General traffic coming from the M.J. Bridge and Begum Bazar Chattri towards Nampally will be diverted at Alaska towards Darusalam, Ek Minar etc on need basis.
10. The General traffic coming from the PCR Junction towards Nampally will be diverted at AR Petrol Pump towards BJR Statue on need basis.
11. Water tankers of HMWS and vehicles of the Fisheries Department bringing fish to the Exhibition Ground will be allowed from Ajanta Gate/Gate No. 2.
12. The vehicles of voluntary organizations carrying food materials with valid passes will be allowed from Ajanta Gate/ Gate No. 2.

All citizens are requested to take alternate routes to their destinations and avoid the above routes during the specified timings and co-operate with the Traffic Police during the period of traffic diversion as above.

**HAWALA MONEY – FOUR HELD**  
**Rs.1,40,20,000/- (RUPEES ONE CRORE FORTY LAKH TWENTY THOUSAND RUPEES)**  
**SEIZED**

On credible information, on 07-06-2019 Commissioner's Task Force, Central Zone Team busted an illegal Hawala Money Transfer at Infront of Krishnakanth Park, Yousufguda, Jubileehills, Hyderabad and apprehended (04) respondents & seized unaccountable amount of Rs.1,40,20,000/- (Rupees One Crore Forty Lakh Twenty Thousand only), (02) Four-wheeler make Hyundai Verna vide Reg No. TS 09 EM 8838 & Skoda Laura vide Reg No. AP 28 DF 4444 and (05) cell phones from them.

**DETAILS OF THE CASE:**

On reliable information under the supervision of Dy. Commissioner of Police, Commissioner's Task Force, Hyderabad City, today i.e., on 07-06-2019 the Central Zone Task Force Team checked the cars bearing no. TS 09 EM 8838 make Hyundai Verna & AP 28 DF 4444 Skoda Laura and found 4 persons **1.** Pavlura Murali Chowdary, **2.** S. Rajesh, **3.** Katuri Jagadish and **4.** P. Srinu, in one of the cars bearing No. TS 09 EM 8838 make Verna found one Trolley Suit case containing cash of Rs.1,40,20,000/- Indian currency. They are transporting money without any documents. On enquiry, they were unable to provide the details of money as such the (04) respondents were taken in to custody and seized the unaccountable money of Rs.1,40,20,000/-, (02) four-wheeler and (05) cell phones from their possession.

The (04) respondents along with seized cash were handed over to Income Tax Department, for further investigation.

The above apprehension was made under the supervision of **Sri. P.
