TRAFFIC ADVISORY

NOTIFICATION

I, Anjani Kumar, IPS, Commissioner of Police, and Additional District Magistrate of the twin cities of Hyderabad and Secunderabad, do hereby order, in the interest of maintaining public peace and order and tranquility particularly in view of the forthcoming Biennial Elections to the Telangana State Legislative Council in respect of Graduates, Teacher's and Local Authorities Constituencies, that prior permission from the Police Department is necessary to organize or conduct any meeting, processions, or rallies etc., within the twin cities of Hyderabad and Secunderabad. The Zonal Dy. Commissioners of Police in whose jurisdiction the proposed meetings, processions, padayatras or rallies initiate, will grant permission to organize or conduct such events. The permission for proposed meetings, processions, padayatras or rallies in the multiple zones, the Organizers, Political Parties and Contesting candidates are requested to apply for written permission from the Addl. Commissioner of Police, (L&O), Hyderabad City, at least before (48) hours so as to enable them to plan for smooth conduct of such events and also use of loud speakers including mobile publicity. They are also requested to co-operate with the City Police in ensuing strict compliance of the instructions of the Election Commission of India for orderly regulation of all such events and use of loudspeakers during election campaign.

This order shall be in force with immediate effect.

NOTIFICATION

In exercise of the powers vested in me under section 21 of Arms Act 1959, I Anjani Kumar, IPS, Commissioner of Police, Hyderabad & Secunderabad and Licensing Authority do hereby order that in the interest of public peace and tranquility, all the holders of Arms Licences residing in twin cities of Hyderabad and Secunderabad except those issued to persons employed on guard duty in the premises of Nationalised Banks, Public Sector undertakings and Security Personnels, the Sports Men who are Members of National Rifle Association at different levels and have to participate in various sporting events in which they need to use their rifles, **shall deposit their weapons with Police Stations concerned or authorized Arms Dealers with immediate effect i.e., on or before 07-03-2019, under intimation to the concerned Police Stations** in connection with the ensuing Biennial Elections to the Telangana State Legislative Council in respect of Graduates, Teacher's and Local Authorities Constituencies to be held in the twin cities on 22-03-2019, failing which penal action will be initiated against the erring persons by confiscating the weapons and also prosecuting them under appropriate provisions of law. **The weapons so deposited may be taken back by the Licence Holders on or after 30-03-2019, after completion of the election process.**
