In the year 2015 one sensational Rape cum Murder for Gain Case reported at Amberpet PS vide Cr.No. 287/2015 U/s. 302, 376, 380 r/w 34, 109 IPC, wherein the accused persons (A1) Pathi Madhu, (A2) Shaik Shareef raped one woman, brutally murdered her and stolen her ornaments, cash and cell phone. In this case the accused persons convicted Life Imprisonment in the month of Feb-2019.

One Murder case of Amberpet PS vide Cr.No. 120/2016 U/s. 302 IPC, wherein the accused Kinnera Rama Krishna brutally murder his own brother by name Shyam. The accused used to harass for money regularly without any work, when the deceased Shyam deny for giving money the accused attack with granite stone and murdered. In this case the accused convicted for Life Imprisonment in the month of Feb-2019.

In the year 2016 the accused Kamalesh Kumar brutally murder his co-worker Vikram Devsai at Mahaveer Enterprises Plywood godown, Mangalhat in a petty quarreled. The same was registered vide Cr.No. 146/2016 U/s. 302 IPC of Mangalhat PS. In this case the accused Kamalesh Kumar convicted Life Imprisonment in the month of Feb-2019.
