ARREST OF ONE ACCUSED AND BJCL, BOTH BROTHERS IN A GRAVE HOUSE THEFT CASE AND RECOVERED OF STOLEN PROPERTY ALL WORTH RS.5 LAKHS IN THE LIMITS OF P.S MANGALHAT, HYD.

Crime No.255/2019, U/s.380 IPC of P.S Mangalhat, Hyd: Dt.30.09.2019.

Complainant : Sri G.Nithin, S/o.G.Nandulal, aged 34 yrs, Occ: works in clothes shop at Begumbazar, R/o.H.No.-----, Mangalhat, Hyderabad.

1) Accused: M.Ajith Kumar @ Anmol, S/o.Late M.Laxman, aged 19 yrs (D.O.B: 06.05.2001), Occ: Labour, R/o.-----, Hyderabad

2) BJCL aged 17 yrs, younger brother of M.Ajith Kumar

BRIEF HISTORY OF ACCUSED AND BJCL:

The accused M.Ajith Kumar and his brother BJCL are residents of H.No.9-1-131/A/1, Khalidaspora, Langer House, Hyderabad. Previously accused & BJCL along with their family members were resided at Balramgally, Mangalhat, Hyderabad in a rented house. The accused is habituated to social vices like alcohol, toddy, inhaling Ganja, whitener, going with prostitutes, etc., due to which accused committing property offences to full his social vices. The BJCL is also habituated with social vices like alcohol, toddy, inhaling Ganja, whitener, etc., due to which BJCL also indulging continuously committing offences to full his social vices. Both are previously involved in property offences and accordingly accused arrested by Police Mangalhat, Kulsumpura and BJCL was apprehended by Police Kachiguda in H.B.by night case.

BRIEF FACTS OF THE CASE:

On 30.09.2019 in the early morning hours at about 04:00 AM, complainant along with his wife & family members left their house to Bhoolaxmi mata temple, Jummerath bazar to offer prayers by partially closing their main gate & doors and complainant mother & his daughter were deep sleep in the house. In the early morning hours, the accused & BJCL with an

intention to commit huge theft to fulfill their social vices, came to Mangalhat area at Raheempura and started searching for suitable house. The accused & BJCL were noticed the complainant along with his family going out by closing doors partially and decided to commit theft in this house. The accused made BJCL to watch at outside the house and alert him and accused went inside the complainant's portion house in ground floor. The accused entered into bedroom and found one Almirah, which is also unlocked. The inner lock of Almirah is also under un-lock, where gold articles & said cash was kept by complainant. Due to which complainant easily committed theft of said gold articles & huge cash of Rs.5.6 Lakhs.

After committing that accused & BJCL went to their sister Smt.Amrita's house at Shivilal Nagar, Mangalhat and hid the cash of Rs.4.6 Lakhs and gold articles. From the stolen amount, accused took Rs.1 Lakh and spent the same lavishly on his social vices.

Yesterday i.e., 01.10.2019, accused went to his sister's house and took Gold necklace & ear rings and left to sell the same at Begum Bazar. At about 06:30 PM, accused was apprehended with possession of Gold Necklace & Ear rings at Puranapool Gandhi Statue while he was proceeding by walk to sell. On which accused shown his sister house, where cash of Rs.4,60,000/- was recovered. The BJCL was apprehended today 02.10.2019 at 0900 hrs at Shivilal nagar.

Appeal to General public:

- 1) The accused & BJCL were identified through CCTV cameras in area installed under community and Nenu Saitham cameras, which were installed on self-interest by local people. They are requested to install more cameras for their safety & security.
- 2) The local people has also supported the Police in identification of accused and continually informing the status of culprits & their family members. The community policing made success in this regard and we appeal to general public to continue their support with Police Mangalhat.

3) It is also requested to keep minimum security to their house and valuable articles keeping place under lock & Alarm system, which prevents the offence.
