NOTIFICATION

In exercise of the powers conferred upon me under section 21 (1) (b) of the Hyderabad City Police Act, I, Anjani Kumar, IPS., Commissioner of Police, Hyderabad, hereby notify, for information of the general public, that, keeping in view the difficulties of general public and patients of Niloufer Hospital with regard to the Traffic congestion at Niloufer Hospital, Nampally, the following traffic restrictions are imposed w.e.f 09-10-2019 to ease-out the traffic congestion on the road between the Forensic Science Laboratory (FSL), Shantinagar, Hyderabad and the MNJ Cancer Hospital. **The road from Forensic Science Laboratory (FSL), Shantinagar, Hyderabad towards MNJ Cancer Hospital is made ONE WAY.**

Accordingly the following traffic restrictions are imposed:

1. Traffic coming from the MNJ Cancer Hospital towards Forensic Science Laboratory (FSL), Shantinagar, Hyderabad will not be allowed via Niloufer Hospital. The public is requested to go towards Ayodhya Junction, Ganga Jamuna Hotel and Forensic Science Laboratory and proceeds towards Shantinagar.
2. Traffic coming from the Forensic Science Laboratory (FSL), Shantinagar, Hyderabad towards MNJ Cancer Hospital will run as usual.

The restrictions will come into force w.e.f 09-10-2019. All citizens are requested to co-operate with the Traffic Police.

**PD ACT INVOKED AGAINST TAMATA SHIVA SINGH @ SHIVA S/O LATE RAM SINGH,
PROPERTY OFFENDER OF MARREDPALLY PS,
NORTH ZONE, HYDERABAD**

Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City issued preventive detention order under the Act No.1 of 1986 against Tamata Shiva Singh @ Shiva s/o late Ram Singh, aged about 19 years, r/o H.No.10-2-14, Plot No.102, Ambedkar Nagar, East Marredpally, Secunderabad and n/o Nepal, **property offender** of Marredpally PS, on 30.9.2019.

The accused Tamata Shiva Singh @ Shiva s/o late Ram Singh has been committing **burglaries, thefts and theft of two wheeler vehicle in the limits of Hyderabad, Cyberabad and Rachakonda Police Commissionerates** to make easy money and lead lavish life.

He has committed **21** offences and has been creating large scale fear and panic among the general public and acting in a manner prejudicial to the maintenance of public order apart from disturbing the peace, tranquillity and social harmony in the society.

Sultan Bazar Police made strenuous efforts and arrested the accused Tamata Shiva Singh @ Shiva s/o late Ram Singh on 3.8.2019 in Cr.No.109/2019 of Sultan Bazar PS and remanded him to judicial custody. The preventive detention order was executed on him on 1.10.2019 and he was lodged in Central Prison, Chanchalguda, Hyderabad.
