NOTIFICATION

In exercise of the powers conferred upon me under section 21 (1) (b) of the Hyderabad City Police Act, I, **Anjani Kumar**, I.P.S., Commissioner of Police, Hyderabad, hereby notify, for information of the general public, that, in order to relieve congestion, to maintain smooth flow of traffic and to ensure public safety and order, in connection with **Grace Cancer Foundation, Hyderabad** conducting 10K, 5K & 2K runs, the following restrictions and diversions will be imposed from 0430 hours to 0700 hours on 13-10-2019.

TRAFFIC DIVERSIONS:

1. Traffic coming from VV statue towards Khairatabad flyover and Necklace Rotary will be diverted at V.V statue towards Shadan and Nirankari Bhavan.
2. Traffic coming from Telugu Thalli will be diverted at Helipad Lane towards Mint-Khairatabad (Bada Ganesh).
3. Traffic coming from Iqbal Minar intending to go towards Upper tankbund will be diverted on Telugu Thalli flyover at Old gate Secretariat
4. Traffic coming from Liberty intending to go towards Upper tank bund will be diverted at GHMC office towards BRKR Bhavan, Telugu Thalli, Iqbal Minar "U" Turn and on Telugu Thalli flyover.
5. Traffic coming from Karbala Maidan towards Upper Tank bund will be diverted at Children's Park towards DBR
6. Traffic coming from Kawadiguda X Road will not be allowed towards sailing club.
7. Traffic coming from DBR Mills traffic will not be allowed towards Children Park.
8. Traffic coming from Ministers road and Ranigunj will not be allowed towards Necklace road and the traffic coming from Ministers Road will be diverted at Nallgutta Jn., towards Ranigunj and traffic coming from Ranigunj will be diverted at Nallagutta Jn., towards Minister road respectively.

General public are requested to avoid above roads and take alternate routes to reach their destination and cooperate with the Traffic Police.

NABBED NOTORIOUS PICK POCKETER - SEIZED (10) TULAS GOLD, Rs. 15,000

CASH, WORTH RS. 4.15 LAKHS.

On 11-10-2019, the sleuths of Commissioner's Task Force, South Zone Team and Kanchanbagh police station staff nabbed **a habitual pocket picker in RTC Buses** who committed theft of Gold chains and net cash in the limits of Hyderabad Commissionerate, **recovered 10 Tulas gold and net cash of Rs. 15,000/-. Total worth of Rs. 4.15 lakhs.**

Accused details:

K.S.Dharam S/o Late K.S.RadhaKishan, age 40 Yrs, Occ: Labourer, R/o H NO: 11-1-1113/8, Afzalsagar, Mallepally, Hyd.

Brief facts:-

The accused **K. S. Dharam**, born & brought up in Mallepally area of Hyderabad city (Popularly known as **Mangar Bashti**) is a notorious/habitual pocket picker. Previously, he involved in **more than 25 cases** of Pick pocketing in various police stations i.e. Sulthan Bazaar, Shahinathgunj etc.,. He is the most wanted offender in the Hyderabad Commissionerate as he is absconding since 2014. Previously he was arrested and sent to jail several times. Even after release from jail he did not change his mindset and committed **(06) Gold chain thefts** and **(02) cash thefts** in RTC Buses in the limits of Bahadurpura, Kanchanbagh, Begumbazar, Humayun Nagar and Nampally police station limits.

He frequently travels in RTC Buses of routes No. 8A, 8M and 2J of Hyderabad City in the rush hours when the buses ply with many passengers. He is a master in Pick Pocketing. Generally he travels along with the passengers in RTC Buses and particularly targets old aged people and commits the offence by diverting their attention.

Further he sells the booty and from the money obtained by selling the gold, he gives small amounts in finance for higher rate of Interest to the needy poor people. He also acts as the supporter to the offenders' families of the same Mangar Basthi where he resides, for the release of accused who were arrested by the police.

The apprehended offender **K.S. Dharam** along with recovered property is handed over to the SHO Kanchanbagh Police Station for taking further action and proposals will be sent to initiate PD Act against the accused.

The Citizens are hereby requested to be wary about the movements of such offenders in the public transportation and to take care of their belongings.

On 09.10.2019 at 13:30 hrs received a complaint from Sri. Kashipuram Venkataiah s/o K Lalaiah, Aga about : 54 years, Occ: Driver, R/o.: Kamanpalli (village), Kulkacharla (mandal),Vikarabad (District) submit that on 09.10.2019 at about 09:30 hrs. He along with his bus conductor Sri. S.Yadaiah S/o S. Jangaiah, age about : 28 years, Occ: Private conductor R/o/: Malkapur village, Pargi mandal,Vikaraba (Dist) left Pargi bus depo in RTC bus bearing number AP 29 Z 3469 went to Kodangal and cameback to pargi , from Parigi he was on his way to Mehdipatnam on the same day i.e., on 09.10.2019 at about 12:45 hrs when he reached at NTR bus stop an unknown person came on two wheeler pelted a stone on his bus due to which the front glass of driver side got damaged at the top causing cracks over the glass. If hese the person who pelted the stone he said he can identify him. Hence, he requested to take necessary action against the person who damaged the bus by pelting the stone on his bus bearing no. AP 29 Z 3469.

A case in Cr No: 289/2019 U/s: 341, 427 IPC and sec 3 of PDPP Act 1984 was registered.

Further it is revealed that, in view of RTC SAMME, the above accused persons A1 to A6 damaged the glass of RTC bus bearing no. **AP 29 Z 3469** by pelting the stone over the bus and damaging the glass of RTC bus, to show their anger against the government, since government is running RTC buses, even the RTC doing SAMME all over the state wide, as there is involvement of more than one person, section 34 IPC was added to the present sections.

The case is being investigated by Sri. D. Srinu, Sub Inspector of Police, Langerhouse PS, Hyderabad under the direct supervision of Sri. Ch. Srinivas, Inspector of Police of Langerhouse PS, Hyderabad.
