

**APPREHENDED TWO ACCUSED AND ONE CHILD CONFLICT WITH LAW
AND SEIZED (32) QUINTALS OF PDS RICE AND ONE GOODS CARRIER
TATA ACE VEHICLE, ONE TWO-WHEELER, AND (03) CELL PHONES**

On 02-02-2019 in the night hours, on credible information sleuths of Commissioner's Task Force, Central Zone Team along with Civil Supply officials intercepted one vehicle Tata Ace near Hanuman Temple, Road No. 8, Mint Compound, Saifabad, Hyderabad and apprehended two-accused and one child conflict with law and seized **(32) Quintals of PDS Rice** and One Goods Carrier vehicle Br.no. TS12UB9694, One Hero Splendor i-smart two-wheeler vehicle Br.no. TS12EA0589 and (03) Cell phones.

Names of the accused:

1. Mohd Zahoor Uddin @ Baba S/o. Late Mohd Mahmood Hussain, age 36 years, Occ. Labour, R/o. Berban Lane, Musheerabad, Hyderabad.
2. Mohd Munazir Uddin @ Munazir S/o. Mohd Naseer Uddin, age 21 years, Occ. Driver, R/o. Near Sai Baba Temple, Bholakpur, Musheerabad, Hyderabad.
3. Ravi aged about 38 years R/o Musheerabad (Absconding)

Brief Facts of the case

The accused persons Mohd Zahoor Uddin @ Baba, Mohd Munazir Uddin @ Munazir and Mohd Rahim @ Rahim all are residing in the limits Musheerabad area at Bholakpur, Hyderabad who were doing labor work. Mohd Zahoor Uddin @ Baba is not satisfied with his income and started PDS Rice business by collecting PDS rice from the known and unknown card holders in Khairathabad, Chintal basthi areas for Rs. 9/- per Kg with the help of Mohd Munazir Uddin @ Munazir diverting the same to Bidhar, Karnataka and selling the same PDS rice for Rs.15/- per Kg to needy customers with the help of Ravi R/o Musheerabad and earning illegal profit from last three months. On 02-02-2019, in the night hours while the above persons transporting PDS rice in TATA ACE vehicle Regd. No. TS12UB9694 and piloting the same vehicle over two-wheeler vehicle Hero splendor i-smart vehicle

Reg. No. TS12EA0589, on credible information Central Zone Task Force Team along with Civil Supply Officials intercepted the above vehicles near Hanuman Temple, Road No. 8, Mint Compound, Saifabad, Hyderabad and apprehended the accused Mohd Zahoor Uddin @ Baba, Mohd Munazir Uddin @ Munazir, and One Child conflict with Law and seized **(32) Quintals of PDS Rice** and One Goods Carrier vehicle Br.no. TS12UB9694 and One Hero Splendor i-smart two-wheeler vehicle Br.no. TS12EA0589. The above accused illegally possessing and transporting the PDS rice and cheating the Government and gaining illegal money. Later they were handed over the 02 accused and One Child conflict with Law to Saifabad police station for necessary action.
