

SEIZURE OF 42-KGs OF GANJA – 05-PERSONS HELD

On 04-02-2019, the Commissioner's Task Force, East Zone Team, Hyderabad, apprehended 05 - persons namely 1) Konety Satyanarayana, 2) Kaveti Ramanand, 3) Gullupalli Haribabu, 4) Kursam Sheshu and 5) Masaparupu Prasad who is in illegal possession of Narcotic Drug i.e., Ganja, Near Jaihind Hotel, Saidabad, Malakpet, Hyderabad and **seized 42 Kgs of Ganja, and One Hyundai Asta i20 car B.No.AP26AL5793.**

Brief Facts:-

Acting on a tip off, the Commissioners Task Force, East Zone Team, Hyderabad, apprehended 05-persons who are in illegal possession of Narcotic Drug i.e., Ganja and seized 42-Kgs of Ganja and One Hyundai Asta i20 car B.No.AP26AL5793, from their possession.

During interrogation the accused person Konety Satyanarayana confessed that he is native of Khammam Dist and use to run grocery shop, Since the income from grocery shop is not sufficient to meet his family expenditures, he decided to earn easy money by procuring Ganja from agency area and transport and sell the same in Hyderabad and earn huge profits illegally. In this process he came into contact with one Gullupalli Haribabu and Masaparupu Prasad of East Godavari Dist, who decided to carry on the Ganja business. Satyanarayana discussed about transporting Ganja with Haribabu and Prasad and offered them to pay good commission, on which both Haribabu and Prasad agreed.

Further accused Konety Satyanarayana contacted his school friend by name Kusram Sheshu and his relative Kaveti Ramanand. He requested both of them in seeking the prospective buyer of ganja in Hyderabad and promised them to pay good share amount, on which they both agreed. Subsequently one week back Konety Satyanarayana went to Uppu village of Vishakapatnam agency area and procured 42- kgs of Ganja from his known source for Rs.1,500/- per kg and called accused persons Haribabu and Prasad to agency area. At the same time he directed his friend by name Sheshu to come to Hyderabad for disposal of Ganja on which accused Sheshu came to Hyderabad by bus from Manuguru of Khammam Dist. On 02-02-2019 accused Konety Satyanarayana along with Haribabu and Prasad picked up Sheshu in Hyderabad and they all went to his relative Ramanand's house at Poosalbasthi, Saidabad.

On 04-02-2019 all the above accused persons started from Poosalbasthi, Saidabad, Hyderabad in Hyundai Asta i20 car B.No.AP26AL5793 (Silver colour) with Ganja to proceed to Dhoolpet, Mangalhat, Hyderabad and when they reached near Jaihind Hotel, Saidabad, Hyderabad, meantime police apprehended them along with Hyundai Asta i20 car B.No.AP26AL5793 (Silver colour) and Ganja.

Earlier accused Gullupalli Haribabu was arrested by PS Rolugunta of Vishakapatnam in similar Ganja case in the year 2018.

The above accused persons and seized property were handed over to SHO, Saidabad PS, for taking further action.
