

**THE ACCUSED WHO COMMITTED AN OFFENSE OF ATTEMPT TO MURDER WITH USE OF A COCONUT KNIFE, STALKING, HARRASSING OF A MINOR GIRL IN THE NAME OF LOVE, IS ARRESTED AND SEIZED THE WEAPON.**

**IN CR.NO: 33/2019 U/S 307, 354-D IPC, SEC. 12 OF POCSO ACT & SEC. 27 OF ARMS ACT.**

The sleuths of PS Kachiguda with the assistance of Special Teams consisting of East Zone Task Force apprehended an accused on 06-02-2019 and seized a coconut knife.

**PLACE OF APPREHENSION:**

AT Railway Parcel office, near Kachiguda Railway Station, Hyderabad.

**BACK GROUND OF THE OFFENCE:**

The accused person C. Bharath and victim minor girl both are residing in the same locality i.e. Satyanagar, Kachiguda. For the last one year the accused person Bharath @ Sonu had been following and harassing the victim girl Ms. Madhulika, while her transit to college by saying that he was in love with her. In this regard her family members approached the SHE Team, accordingly, the SHE team officials had given counselling to the accused Bharath @ Sonu, but the accused Bhrath@Sonu did not change his attitude and continued to observe her movements on the roof of his home. On 06-02-2019 at about 0800 hours, while the victim girl left to her college, meantime the accused person Bharath@Sonu attacked her with a coconut knife beside her residence indiscriminately to kill her by keeping her refusal in mind and on the hue and cry of her, on seeing her mother and neighbours he sped away from the spot. In the attack she sustained severe bleeding cut injuries over her head, neck and both hands. Immediately, the victim was shifted to Sai Krishna Neuro Hospital, Kachiguda by her mother and neighbours, after examination on the doctors advised shifted to Yashoda hospital, Malakpet, Hyderabad, she is undergoing treatment. The accused was arrested and seized coconut knife at his residence.

This case is being investigated by Sri C. Yadender, Detective Inspector of Police, PS Kachiguda with the assistance of SI Sri V. Laxmaiah, under the close supervision of Sri S. Sudhakar, Asst. Commissioner of Police, Kachiguda Division under the guidance of Sri Govind Reddy Addl.DCP East Zone, and Sri M. Ramesh, Dy. Commissioner of Police, East Zone.
