**TWO ACCUSED PERSONS IN A BRUTAL MURDER CASE OF RAMGOPALPET PS  
APPREHENDED.**

On 11.02.2019 the Ramgopalpet police apprehended two persons namely 1) A1 Elagandula Satyanarayana @ Babu and 2) A2- Pamula Srinivasa Rao @ Srinu who were involved in a Murder case vide Cr.No.23/2019 U/s 302 IPC of Ramgopalpet PS, Hyderabad. Offence occurred on 07.02.2019 and complaint received on 08.02.2019 at 1500 hrs.

Today i.e. on 11-02-2019, apprehended the above noted accused persons who are involved in a brutal murder of a person namely Rahul Age:- about 25 yrs, Occ:- Function Hall Worker R/o Footpath Ranigunj, Secunderabad on 07-02-2019 at inside the compound premises of Agarvanshi house building, Ministers Road , Secunderabad. under the limits of Ramgopalpet PS. During interrogation both the accused persons confessed that the deceased and accused are friends, working in function hall and rag pickers. The deceased used to extort money from his colleague workers and even attack them if they do not give their money according to his demand. About three months back Rahul demanded money from A1 when he refused to give money he attacked him with a tile stone, due to which A1 received two injuries on his head. As the wounds got infection and A1 was unable to work he joined at an orphan home at Begumpet and got treatment. On Thursday A1 was discharged from the home as the wound cured well. A1 came to Saibaba temple, Minister Road to get free meals, there A1 met A2. The deceased Rahul also came there in drunken condition and tried to attack again. The deceased also Harrassed A2 and also attacked his girl friend recently. A1 and A2 felt disgusted with the attitude of Rahul and decided to kill Rahul. They brought two spirit bottles and gave to deceased Rahul, he consumed almost two bottles of spirit and became unconscious. A1

and A2 found one big stone near the gate of that building. Srinu lifted that stone took inside, kept near the head of Rahul and A1 hit the head of Rahul to that stone. After that to confirm the death of deceased A2 also blow his head to the same stone and fed away towards Raniganj Railway Bridge. After verifying CC Cameras Police identified the accused persons moving with the deceased on the incident day. Today i.e. on 11-02-2019 in the morning hours, based on reliable information police Ramgopalpet apprehended the accused near Lingampally Railway Station, Hyderabad.
