**PD ACT INVOKED AGAINST MD.MAHBOOB S/O LATE MD.SHAHBUDDIN,
DRUG OFFENDER OF SHAH ALI BANDA POLICE STATION, SOUTH ZONE,
HYDERABAD**

Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City issued a preventive detention order under the Act No.1 of 1986 against Md.Mahboob s/o late Md.Shahbuddin on 12.2.2020.

The detenu Md.Mahboob s/o late Md.Shahbuddin, aged about 29 years, Occ: Driver, r/o Brindavan Colony, Hakeempet Kunta, Tolichowki, n/o H.No.1-56, Rudrairam, Yellareddy mandal, Kamareddy district was peddling Narcotic Drugs among the people **in the limits of Hyderabad Police Commissionerate** with his associate in an organized manner. He has developed widespread network, wherein he uses cell phones and other information technology devices to escape police observation.

He committed an offence in peddling of Narcotic Drugs among the people in the recent past and his illegal and highly dangerous activities in peddling of Narcotic Drugs among the people has been endangering the lives of youth and innocent people causing irreparable damage to the body organs including the Central Nervous System, thereby crippling the mental and physical health of the people addicted to drugs. His activities are prejudicial to the maintenance of public order and public health at large.

Shah Ali Banda Police arrested the detenu Md.Mahboob s/o late Md.Shahbuddin on 27.12.2019 in Cr.No.181/2019 u/s 8 (C) r/w 20 (b) (ii) (c) of NDPS Act, 1985 of Shah Ali Banda Police Station, **seized 400 kgs of "Ganja"** from his possession and from the possession of his associates and was remanded him to judicial custody. The preventive detention order was executed on him on 18.2.2020 and he was lodged in Central Prison, Chanchalguda, Hyderabad.

Hyderabad Traffic Police is continuing its drive against the drunken drivers to ensure road safety. **(1821)** drivers were found under the influence of alcohol during the month of **February-2020**. Charge sheets were filed against them and were produced in the Hon'ble 3rd and 4th Metropolitan Magistrate Courts, Nampally, Hyderabad. In this regard 3rd and 4th Metropolitan Magistrate Courts awarded imprisonment to the **(204)** respondents and Permanently Cancelled / Suspended Driving licenses of **(02)** Persons for a period as mentioned below. The Hon'ble Courts imposed fine amount of **Rs.1,85,07,900/-** on traffic violators. All the violators sentenced for imprisonment were sent to Chanchalguda Jail.

APPREHENDED TWO INTER STATE CHILD TRAFFICKERS- RESCUED (14) CHILDREN WHO ARE ENGAGED IN MAKING BANGLES.

On the sleuths of, the Commissioner's Task Force, South Zone Team, Hyderabad along with Chatrinaka Police rescued 14 childrens, in which most of the below 14 yrs, and apprehended two persons who engaged them as bounded labors at their bangle making centers.

Apprehended accused:

1. **Tarun chowdary**, S/o Kashish Chowdary, age: 30 yrs, Occ: Business, N/o Gharkatari (V), Goraur Post, Nalanda(Dist), **Bihar State**, present residence: H.No. 18-8-444/1/150, Raghavendra colony, Chatrinaka, Hyderabad.
2. **Suntush Mangi**, s/o Ration Mangi, age: 27 yrs, N/o Horma(V),Nimchakbathani(M) Gaya(dist), **Bihar State**, Present residence, H.NO. 18-7-455/99, Patel Nagar, Chatrinaka, Hyderabad.

Brief facts:

The accused **Tarun Chowdary** and **Suntush Mangi** are native of Bihar State. Few years back, they both migrated to Hyderabad, running Bangle making centers at Raghavendra colony and Patelnagar in the limits of Chantrinaka. For that, they both hatched a plan to secure chaild labour from their native villages. Two months back, they went to their native place, managed poor parents in the means of salary amount of Rs. 5000/- for month and engaged the minors at their Bangle making centers which is more dangerous to the health of children. **Tarun Chowdary** and **Suntush Mangi** both brought the children's from Bihar to Hyderabad, wrongfully restrained them and using as labors at their respective Bangle making centers.

Basing on credible information, the South Zone Task Force, Hyderabad along with Chatrinaka Police raided two places simultaneously and apprehended two traffickers and rescued (14) children (in which most of the children are below 14 years) from Bangles manufacturing units and the same was informed to Child Help Line officials and handed over to PS Chatrinaka for further action.

The above arrests were made under the supervision of **Sri. S. Raghavendra, Inspector of Police**, Commissioner's Task Force, South zone Team Hyderabad City **and SIs S/Sri N. Srishylam, Mohd Thakiuddin, V. Narender & Staff** and Chatrinaka Police.

Brief facts of The case is:

On 01/03/2020 at 1920 hours received complaint Smt. Fatima Unnisa, D/o: Late Mohd Afzal, age: 30 years, Occ: Social Worker, R/o: H. no: 2-2-76/9, Turab nagar, Amberpet, Hyderabad, in which she submitted that on 25/02/2020 at about 1400 hours one person by name Mohd Saber @ Volta Saber called her and informed that one person is ready to purchase her house and asked to come to his house and Nabeel Colony, Kottapet, Salala. At about 1500 hours she along with her sister by name Rafath Unnisa, age: 25 years, went to his house. Saber has introduce them with one person by name Ibrahim Shukurullah and offered her to marry him. As she was not interested, she had rejected his offer then he asked Rafath Unnisa, then she also rejected his offer. Then at about 1830 hours they returned back to house. After that at 2130 hours, she found Rafath is not in house. When she asked family members about her, they said that they don't know and she thought that she went to meet her son at her in laws house. On 27/02/2020 at about 1530 hours she went to Saber's house and asked them about Rafath, then they denied saying anything about her. When she got angry on them and shouted, then Sameena Saber's wife, came, slapped her and took away her Purse and mobile phone. Later they made her to wait till 29/02/2020. On the same day at about 10:30 hours got her phone and purse so she called her brother there. Then on forcefully asking about Rafath, Saber given them her address. Somehow they reached to Rafath at about 1530 hours at H. no. 18-11-67/2/C, Salala Barkas and shocked to see Ibrahim there. When asked him about the situation then he told that Saber has sold her for money. Then asked Ibrahim to come to Police Station then he tried to run away along with his luggage, however they took his Passport from him, so that he can't go anywhere. Then they went back to their house and when asked Rafath about the incident, then she stated that on 25/02/2020 after reaching home, at about 1930 hours, she made a phone call to Sameena, as Sameena asked her to call. Then Sameena asked Rafath to come to her house. When she went there, then at about 2130 hours, Sameena took her to Ibrahim's house at Salala, Barkas and left her there. Since then Ibrahim wrongfully confined her, had forcefully sexually intercourse without her consent and burned her foots with Cigarette

A1 contacted with A2 Saber, and informed him that A1 going to marry Hyderabad woman, A2 Saber agreed to arrange for my second marriage. On 01/03/2020 In the afternoon at about 1500 hours Victim woman along with her sister came to the house of A2. Saber, A2 Saber has introduce them to A1. Informed his intention to marry Victim Rafath and her sister. those two ladies shown disinterest. A1 was attracted with one Rafath Those two ladies have returned to their from the house of A2 Saber, Then A1 I asked A2 Saber and his wife A3 Sameena to convince the lady Rafathunnisa for marriage. In the evening A2 Saber and his wife A3 Sameena called the lady to their house and made Victim to sit in the bedroom. After some time A3 Sameena i.e Saber wife came out of the room, and asked Victim to go inside. A1 went inside the bed room and spoke with the Victim lady to marry A1, but she refused. A1 forced her and committed sexual intercourse against her will repeatedly When Victim did not cooperate with A1. A1 have put burning cigarette on Victim foot to made her to listen to me.
