APPREHENDED NOTORIOUS HOUSE BURGULAR SADDAM ALI @ IMRAN--
RECOVERED GOLD ORNAMENTS WG. ABOUT 413 GRAMS ALL WORTH
ABOUT Rs. 17 LAKHS.

On 03-02-2020, the sleuths of Commissioner's Task Force, South Zone Team, Hyderabad along with Nallakunta Police apprehended one habitual notorious house burglar by name Md. Saddam Ali @ Imran and detected (02) Grave House breaking by Night offences of Nallakunta and Chilakalguda of Hyderabad City and recovered gold ornaments Wg. About 413 grams, all worth of Rs. 17 Lakhs at the instance of accused.

Details of accused:-

Md. Saddam Ali @ Imran Ali, S/o Khasim Ali, Age: 24 yrs, Occ: Welder, R/o H.No. 43-94/C, Hanuman Nagar, RTC Colony, Moula-ali, Hyderabad.

Brief History of accused:-

- Md. Saddam Ali, born and brought up in Moula-ali, Malkajgiri of Ranga Reddy.
- He is a notorious/habitual house burglar. Involved in **more than (51) cases** of house burglaries.
- In the year, 2015 he along with his associate **Pothu Raju @ Raju R/o Malkajgiri** started committing offences in the limits of Malkajgiri Police station and arrested.
- Later, in the year 2017 both were arrested in **(15) House Burglaries in Warangal Commissionerates** and in the year 2018 both were arrested in **(33) House Burglaries in Tri- Commissionerates.**
- In the year, 2018 Gopalpuram Police detained the accused under **PD Act.**
- In the month of **January 2020** the accused released on bail, but he did not mend his attitude, again he committed offences in the limits of **Chilakalguda** and **Nallakunta** Police Stations.

Modus Operandi of the accused:

As the accused is known to the Police personnel and other criminals, the offender frequently shift his places. He usually rests on railway platforms or waiting rooms, accused choose residential area **beside railway tracks** to avoid identification and easy escape, he will enter into the locked houses by breaking main door or windows, as the places are quiet isolated and free from identification from **CCTVs**.

Today, basing on CCTV footages and on credible information Commissioner's Task Force, South Zone, Hyderabad along with Nallakunta police, apprehended the accused and recovered the stolen property. The accused and seized property handed over to S.H.O. Nallakunta PS for taking further action.

NOTIFICATION

In exercise of the powers conferred upon me under section 21 (1) (b) of the Hyderabad City Police Act, I, ANJANI KUMAR, I.P.S, Commissioner of Police, Hyderabad City do hereby notify, for information of the general public that in order to facilitate proper regulation of traffic and ensure public safety in connection with the widening of road at Panjagutta Grave yard (Chutneys) and construction of steel Bridge over Grave yard beside Chutneys, Panjagutta, the following traffic restrictions and diversions will be enforced for a period of 3 months, w.e.f. 04-03-2020 to 03-06-2020.

Due to widening of road and construction of steel Bridge over Grave yard beside Chutneys, Panjagutta, the heavy vehicles like RTC Buses/Private Buses/School and College buses/Lorries/DCMs/Water Tankers/ Petrol Tankers/Cement Ready Mix Vehicles etc., will not be allowed beyond SNT junction towards NFCL and Panjagutta. Therefore the above said heavy vehicles owners and drivers are requested to take alternate routes while coming from filmnagar junction, Road no.45 junction and Road No.36 etc. They are advised to take the following suggested alternate routes:

1. From Jubilee Hills Check Post - Venkatagiri - Krishna Nagar - Yousufguda check post - Yousufguda Basti (Setwin office) - Maitrivanam, Ameerpet.

(OR)

2. From Jubilee Hills Check post - Road No.45 Jubilee Hills - BVB Junction - Orissa island - road no.12 Banjarahills - Road no. 1, Banjarahills.

All citizens and other commuters are also requested to take alternate routes to reach their destinations and avoid the above route and co-operate with the Traffic Police during the period of road widening and steel bridge work.
