

PD ACT INVOKED AGAINST SHAIK MOHAMMED MOHSIN @ CHINNA S/O MOHAMMED IBRAHIM, PROPERTY OFFENDER OF FALAKNUMA POLICE STATION, SOUTH ZONE, HYDERABAD

Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City issued preventive detention order under the Act No.1 of 1986 against Shaik Mohammed Mohsin @ Chinna s/o Mohammed Ibrahim, **property offender** of Falaknuma Police Station on 6.3.2020.

The detenu Shaik Mohammed Mohsin @ Chinna s/o Mohammed Ibrahim, aged about 22 years, Occ: Pan Shop business, r/o near Nice Hotel, Vattepally, Hyderabad, property offender of Falaknuma Police Station **committed offences including theft of mobile phones, robbery and extortions in the limits of Cyberabad and Hyderabad Police Commissionerates.**

He has committed 5 property offences in the recent past and has been creating large scale fear and panic among the general public and acting in a manner prejudicial to the maintenance of public order apart from disturbing the peace, tranquillity and social harmony in the society.

Falaknuma Police arrested the detenu Shaik Mohammed Mohsin @ Chinna on 24.10.2019 in Cr.No.319/2019 u/s 384 IPC of Falaknuma Police Station and remanded him to judicial custody. The preventive detention order was executed on him on 7.3.2020 and he was lodged in Central Prison, Chanchalguda, Hyderabad.

The Cyber Crime Police, CCS, DD, Hyderabad City arrested one person Mohammed Amir Sohel, age: 26 years, Hyderabad who is morphed his colleagues pictures with nude content and sending the same to his colleagues by creating different social media accounts in objectionable manner.

Facts of the case:

The brief facts of the case are that on 25.02.2020 at 12:50 hours, received a complaint in which the complainant stated that, someone sending emails to him and his company's people official email address with morphed pictures and vulgar words continuously from different email addresses. Hence, he requested for necessary action. Basing on the above contents of the complaint registered a case in Crime No.434/2020 U/s. 67 IT act-2008 for further investigation.

As per the investigation, accused was unhappy due to behavior of some people in the company. Later, the accused hatched a plan to take revenge against complainant and his colleagues. As such he has created number of fake accounts and sent vulgar messages continuously to the company employees official mail ID's by morphing complainant and his daughter pictures with objectionable content in objectionable manner.

APPREHENDED ONE CHAIN SNATCHER WHOSE DETAIN ORDERS PENDING AGAINST HIM AT SR NAGAR PS

On 16-03-2020, the sleuths of Commissioner's Task Force, West Zone team apprehended one Notorious Snatcher by name Chakali Ravi, whose PD Act detain orders pending against him at SR Nagar Police Station **vide No.SB(1) No.190/PD-1/HYD/2019, Dated: 08-08-2019 of CP, Hyderabad City.**

Details of the Accused:

1. Chakali Ravi S/o Ch.Laxmaiah, aged 27 yrs, Occ: Working in Hotel at Zaheerabad, R/o Bagathsingh Nagar, Near Bodraigalli, Beside Vignan School, Chintal, Hyderabad, N/o H.No.1-80/2, Kekkarwada, Zarasangam, Sangareddy District.

Modus operandi:-

The accused Chakali Ravi is native of Kekkarwada(V), Zarasangam(M), Sangareddy District. He is illiterate. About twelve years back he came to Balanagar, Secunderabad for livelihood and worked in different areas in Hyderabad as labour. At present he is working as labour in Shabadin Hotel, Zaheerabad.

In the month of February-2019 the accused Chakali Ravi committed chain snatchings in the limits of Hyderabad City and Cyberabad, arrested by following chain snatching cases and remanded to judicial custody by SR Nagar PS of Hyderabad City in the month of March-2019.

- 1) Cr.No.139/2019 U/s 392 IPC of SR Nagar PS, Hyderabad.
- 2) Cr.No.97/2019 U/s 392 IPC of Kukatpally PS, Cyberabad.
- 3) Cr.No.124/2019 U/s 392 IPC of Kukatpally PS, Cyberabad.

After four months the accused Chakali Ravi was released from Jail. Later the SHO, SR Nagar PS, Hyderabad City sent proposals to detain him under PD Act and obtained detain orders vide **No.SB(1) No.190/PD-1/HYD/2019, Dated: 08-08-2019 of CP, Hyderabad City.** Since then the accused Chakali Ravi is absconding.

All possible efforts are made to trace out the accused Chakali Ravi and on 16-03-2020, on credible information the West Zone Task Force team, Hyderabad apprehended the accused Chakali Ravi and handed over him to SHO, SR Nagar PS for further necessary action.

Today i.e. on 17-03-2020 SR Nagar Police produced him before the Superintendent, Chanchalguda Central Prison, Hyderabad for judicial remanded vide **No.SB(1) No.190/PD-1/HYD/2019, Dated: 08-08-2019 of CP, Hyderabad City.**
