

**PD ACT INVOKED AGAINST MOHD.AKBARUDDIN FAROOQUI @ AKBAR
S/O MOHD.MOHSIN, PROPERTY OFFENDER OF FALAKNUMA POLICE
STATION, SOUTH ZONE, HYDERABAD**

Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City issued preventive detention order under the Act No.1 of 1986 against Mohd.Akbaruddin Farooqui @ Akbar s/o Mohd.Mohsin, **property offender** of Falaknuma Police Station on 6.3.2020.

The detenu Mohd.Akbaruddin Farooqui @ Akbar s/o Mohd.Mohsin, aged about 26 years, Occ: Welder, r/o H.No.8-15-33/16/1, near Ali Masjid, Mailardevpally, property offender of Falaknuma Police Station **committed offences including theft of mobile phones, robbery and extortions in the limits of Cyberabad and Hyderabad Police Commissionerates.**

He has committed 5 property offences in the recent past and has been creating large scale fear and panic among the general public and acting in a manner prejudicial to the maintenance of public order apart from disturbing the peace, tranquillity and social harmony in the society.

Falaknuma Police arrested the detenu Mohd.Akbaruddin Farooqui @ Akbar on 24.10.2019 in Cr.No.319/2019 u/s 384 IPC of Falaknuma Police Station and remanded him to judicial custody. The preventive detention order was executed on him on 7.3.2020 and he was lodged in Central Prison, Chanchalguda, Hyderabad.

**PRESS NOTE IN CR.NO. 47/2020 U/SEC. 376D, 376DA IPC & SEC. 5
R/W. 6 OF POCSO ACT 2012 OF P.S. KAMATIPURA, HYDERABAD.**

The Kamatipura Police have arrested two accused persons and apprehended three Juvenile in Conflict with law for committing rape of two minor victim girls separately at different occasions.

The name of the arrested accused person:

A1] Mohd. Shafeeq @ Safiq @ Safi S/o. Md. Shareef, aged. 20 yrs, Occ. Key Maker R/o. Jamal-Bee-Ka-Takiya, Doodh Bhowli, Fathe Darwaza, Hyderabad.

A2] Mohammed Saif Ali S/o. Mohd. Fasi Ali, aged. 18+ yrs, Occ. Student R/o. Doodh Bowli, Fathe Darwaza, Vazir Ali Masque, Bahadur Pura, Hyderabad.

A1 & A2 arrested on 18-03-2020 at 1100 hours

and apprehended three Juvenile in Conflict with law aged 14 years and 17 years and 17 years respectively.

Modus Oprandi:

One of the juvenile has befriended a victim girl aged 17 years about one year back in the name of friendship and love, the juvenile and accused persons known to each other since one year. The juvenile and victim girls are School and tuition mates. While the victim girl aged about 17 years was returning back to her home from tuition, the juvenile firstly took her near to Graveyard in front of Vazir Ali Mosque and assaulted her sexually by taking advantage of her innocence. Later he shared about his experience with his juvenile and adult friends who also took advantage of her innocence and assaulted sexually her at different times at different locations like Under Construction Building near Chandulal Baradari and toilet of a Hospital, at Doodhbowli, Hyderabad. Later one of the Accused A2 Saif Ali developed friendship with sister of Victim girl who is aged about-14 years and took her to the under construction building at Chandulal Baradari and sexually assaulted her. The accused persons A1 & A2 and the Juvenile in Conflict with law 1 to 3 were apprehended and arrested within 24-Hours of lodging the complaint.

The arrests and apprehensions were made by Sri. G. Rambabu, Inspector of Police, P.S. Kamatipura, Hyderabad with assistance of Sub Inspectors and Staff of PS Kamatipura, under the supervision of Sri. B. Anjaiah, Assistant Commissioner of Police, Charminar Division, Hyderabad.
