On the complaint of Chief manager of Bank of Maharashtra, Asset Recovery Branch, Hyderabad on 12-02-2020 a case vide Cr. No. 32/2020 u/sec 406, 420, 465, 468, 471 r/w 34 IPC registered at CCS, DD, Hyderabad against G. Niranjana and others. Wherein G. Niranjana colluded with Satish Kolluru, Vodde Krishna, Vodde Laxminarayana and Vodde Prabhakar prepared the fake and fabricated will deeds on the name of death persons (V. Lakshmaiah and V. Yadagiri) registered AGPA and then later registered Sale deed in favour of G. Niranjana. The accused G. Niranjana applied the Cash Credit Loan at Bank of Maharashtra, Khairatabad Branch in the year 2012 by submitting the fake and fabricated documents. The then Chief Manager i.e., Rudra Shankar Mohapatra @ R. S. Mohapatra sanctioned the Cash Credit Loan an amount of Rs. 180 lakhs basing on report of legal advisor V. Narsing Rao to the accused G. Niranjana. After obtaining loan the accused G. Niranjana defaulted the payment of the loan.

On the investigation it is revealed that the accused the then Chief Manager Rudra Shankar Mohapatra @ R. S. Mohapatra deliberately sanctioned the loan without proper documentation and caused wrong full loss to the Bank of Maharashtra and wrong full gain to them.

On Credible information on 31-08-2020 arrested (1) Rudra Shankar Mohapatra @ R. S. Mohapatra, (2) V. Narsing Rao produced before the Hon'ble court for Judicial Remand. Earlier the accused G. Niranjana, Vodde Krishna, Vodde Laxminarayana and Vodde Prabhakar was arrested in this case.

The case is being investigated by Sri. M. Srinivasa Rao, Inspector of Police, WCO Team I, CCS, DD, Hyderabad and his team under the guidance of Sri. K. Ram Kumar, ACP, (WCO) A Division, CCS, DD, Hyderabad and also under the direct supervision of Sri. N. Mahendar, Addl. DCP, EOW & SIT, DD, Hyderabad.
