

NABBED DRUG PEDDLERS - SEIZED (90) GRAMS OF MD (MEPHEDRONE) DRUG BY CENTRAL ZONE TASK FORCE

On 10-09-2020, the sleuths of Commissioner's Task Force, Central Zone Team apprehended (2) accused persons who were found in possession of Narcotic substance/Drug i.e. MD (Mephedrone) drug in order to deliver the same to needy customers in the limits of Amberpet PS, Hyderabad. **Seized (90) grams of MD Drug, (1) Pocket weighing machine and (3) Cell phones** from their possession.

Details of Accused persons:

1. Manoj Kumar Panwar @ Manoj S/o Laxman Ram, aged 24 years, Occ: BA student at Mahadev College, Sankar(V), Sanchore(T), Jalor(Dist.), Rajasthan R/o -----
2. Manohar Bishnoi @ Manohar S/o Late Bagaram, aged 26 years, Occ: Steel Railing works, R/o -----

Facts of the case:

Both the accused persons are native of Sanchore(Tq), Jalor (Dist.), Rajasthan and are friends. About six months back Manohar Bishnoi @ Manohar came to Hyderabad for his livelihood and started steel railing works at Meerpet, Hyderabad. Due to meager earnings he is unable to run his family. In the mean time Manoj Kumar Panwar @ Manoj contacted his friend Manohar Bishnoi @ Manohar and asked to work with him in selling MD (Mephedrone) Drug which he brought from one Jalaram R/o Sanchore (Tq), Jalor (Dist.), Rajasthan, to earn easy money illegal way, for which Manoj agreed to pay Rs.20,000/- per month to Manohar. As per their plan the accused Manohar is selling the MD drug to the needy customers in Hyderabad on higher price i.e. Rs.3,000/- to Rs.3,500/- per 1 gram. About four days back the accused Manoj Kumar Panwar @ Manoj came to Hyderabad along with (100) gms of MD Drug.

On 10-09-2020 while the accused Manohar Bishnoi @ Manohar waiting for prospective customers near Polytechnic Bus Stop, Amberpet and trying to sell the MD Drug to the needy customers, in the meantime Police apprehended him along with 3 sachets of MD drug containing 1 gm in each sachet and two Cell phones from his Pocket. On questioning him he confessed and lead police to H.No.3-16-106/3/E/2, Venkatreddy nagar Colony, Ramanthapur, Hyderabad where the accused Manoj Kumar Panwar @ Manoj was apprehended and on searching the house, police found (87) gms of MD drug and one pocket digital weighing machine in the house along polythene covers, Cell Phones and other material.

In this case the accused Jalaram R/o Sanchore (Tq), Jalor (Dist.), Rajasthan, is at large.

The accused persons along with the recovered contraband Narcotic Drug i.e. MD (Mephedrone) drug and other property were handed over to SHO, Amberpet PS vide Cr.No.315/2020 U/s 8(c) r/w 20(b)(ii)(c) of NDPS Act-1985 of Amberpet PS.
