The Mirchowk Police served notices of forfeiture of bond for good behaviour on Ahmed Hussain @ Amer @ Gajini, S/o Late. Abdul Hussain, aged 28 years, who is in Chanchalguda jail for involving in recent murder case of Rein Bazar P.S. He was called upon to pay the said **penalty of rupees one lakh fifty thousand in two bond over cases of Mirchowk P.S.**

### Accused details :

Ahmed Hussain @ Amer, S/o Late. Abdul Hussain, aged 28 years, R/o H. No. 22-3-947/33/A/1, Near Setwin Office, Puranai Haveli, Hyderabad.. **(Rowdy Sheeter of Mirchowk Police Station )**

### BOUND OVER CASES:

1. On 06.11.2018 he was bound over, vide Cr. No. 204/2018 U/s 41 (A), 107 Cr. P. C. Of P.S. Mirchowk, Hyd. to maintain good behaviour for a period of one year and released on the same day by executing personal bond of **Rs. 1,00,000/-**, without surety, by Spl. Executive Magistrate (RDO), Nampally.

Later the accused person was involved in (3) Cases 1) Cr. No. 183/2018 U/S 324, 448, 506 r/w 34 IPC of **P.S. Dabeerpura**. 2) Cr. No. 71/2019 U/s 307 r/w 34 IPC 25 (1) (a) Arms Act of **P.S. Dabeerpura**, and 3) Cr. No. 72/2019 U/s 341, 506 IPC of **P.S. Dabeerpura**, Hyderabad, with in the period of one year.

2. On 20.06.2020, he was bound over in Cr. No. 132/2020 U/s 41 (A), 107 Cr. P. C. Of P.S. Mirchowk, Hyderabad, to maintain good behaviour for a period of one year and released on the same day by executing personal bond of **Rs. 50,000/-**, without surety, by Spl. Executive Magistrate (RDO), Nampally.

Later the accused person was involved in Cr. No. 168/2020 U/s 302, 120(b), 506 r/w 34 IPC & Sec. 25(1)(b) of Arms Act of **Rein Bazar P.S.**, within the period of 6 months.

### Previously he was involved in so many cases: i.e.

1. Mirchowk P.S - (05) Cases.
2. Nampally P.S – (01) Case.
3. Dabeerpura P.S - (05) Cases.
4. Santhosh Nagar P.S.(01) Case
5. Banjara Hills P.S. (02) Cases

### Previously he was detained in P.D. ActL:

1. On 07.04.2015 detained under PD Act. By Dabeerpura P.S.
2. Again on 11.01.2018. But was released on 06.07.2018 before completion of detention period through the orders of Hon'ble High Court of Telangana State.
3. He was detained for the third time under PD on 26.07.2019. Later he was released on 01.12.2019.

Ahmed Hussain @ Amer, is a offender, he always equipped with Arms and is mostly associated with the other offender and is frequently involved in Un-lawful activities and bodily

offences. He has been creating terror in the minds of public and thereby disturbing peace and tranquillity in the area by his criminal activities.

On 14.09.2020 The Hon'ble Special Executive Magistrate, Hyderabad District, has issued NOTICE TO RESPONDENT ON FORFEITURE OF BOND FOR GOOD BEHAVIOUR TO ACCUSED AHMED HUSSAIN @ AMER,. **CALLED UPON TO PAY THE SAID PENALTY OF RUPEES ONE LAKH FIFTY THOUSAND IN TWO BOUND OVER CASES OF MIRCHOWK P.S.**

As per the directions of the Hon'ble Magistrate, on 17-09-2020 served the Notice against the offender in Chanchalguda Jail.
