**NABBED 02 PERSONS-SEIZED BANNED FOREIGN CIGARETTES OF PARIS,
ALL WORTH OF Rs. 15 LACKS.**

The sleuths of Commissioner's Task Force, South Zone Team, Hyderabad along with Chandrayangutta Police apprehended two persons who are supplying foreign Paris cigarettes illegally and seized the property along with Ashok Leyland vehicle bearing no TS12UC9433. Total worth of seized property is 15,00,000/-.

Details of accused:-

- 1) **Syed Ilyasuddin** S/o Syed Nazeeruddin Age: 31Yrs, Occ: Driver R/o Shaker Gunj, Shah ali banda, Hyderabad.
- 2) **Mohammed Sameer** S/o Mohammed Siraj, age: 28Yrs, Occ: Labour R/o Ghazi Banda, Bahadurpura, Hyderabad.
- 3) **Aslam** (Absconding).

Details of seized property:

- 1) **Paris Cigarettes 30 Cartoons** (Total 14,500 cigarettes Packets).

BRIEF FACTS:-

One Aslam R/o Kalapather, procuring and selling banned Paris foreign cigarettes to the Pan shops, Kirana Stores, and Other Petty vendors in the Hyderabad city and surrounding areas. He is procuring banned cigarettes from Delhi, Gujarat States. Smuggling foreign cigarettes is lucrative business to black marketers make a huge profit as they avoid customs duty.

For the said business the prime accused hired two persons namely **Syed Ilyasuddin** and **Mohammed Sameer** for transporting the banned cigarettes in Hyderabad and surrounding areas. With their influence and reputation in the market they acquired needy customers and illegally supplying cigarettes. Many foreign cigarettes contain a very high content of tobacco dust which is especially injurious to health, this banned foreign cigarettes doesn't have caution Hazardous like **CIGARETTE SMOKING MAY BE HAZARDOUS TO YOUR HEALTH, ITS NICOTINE AND TAR CONTENTS ON THE CIGARETTE PACKS.**

The arrested accused along with seized material were handed over to SHO, Chandrayangutta PS, Hyderabad for further investigation
