

ORGANIZED CRICKET BETTING RACKET BUSTED – FOUR HELD

On credible information the sleuths of Commissioner's Task Force, North Zone Team, Hyderabad busted organized cricket betting racket & conducted raid at Cricket betting (Gaming) house situated at **Flat no. 202, 2nd floor, Dwaraka Residency, Indirapuri Railway Colony, Marredpally** and apprehended **(04) accused persons** 1)Khimani Saleem (Organizer/Bookie), 2) Anwar Akbar Khoja(sub-bookie), 3) Sandeep Agarwal & 4)Kontham Abhilash (punters/agents), wherein the accused persons are organizing cricket betting under main Cricket bookie Remmy R/o. Nagpur, Maharashtra state and accepting betting amount directly and indirectly, over cell phone from punters for ongoing **IPL 2020** Cricket matches and gain illegally easy money.

➤ **DETAILS OF ACCUSED PERSONS:-**

1. Khimani Saleem S/o. Sadruddin, age.41 yrs, Occ. Business R/o. Marredpally, Secunderabad (Betting organizer/ **bookie**)
2. Anwar Akbar Khoja S/o. Akbar, age. 44 yrs, Occ. Chips maker R/o. Sairam Nagar Colony, West Marredpally, Sec'bad (**Sub-bookie**)
3. Sandeep Agarwal S/o. late Moolchand Agarwal, Occ. Kirana shop R/o. Marredpally, Secuncerabad (**Punter**)
4. Kontham Abhilash S/o. K.Chandrashekar, age. 41 yrs, Occ. business R/o. Marredpally, Secunderabad (**Punter**)

➤ **BRIEF FACTS OF THE CASE:-**

The accused Khimani Saleem is residing at Flat no. 202, 2nd floor, Dwaraka Residency, Indirapuri Railway Colony, Marredpally. He is running Chips business for his livelihood. He having habit of betting ongoing Cricket match. He hatched a plan to gain easy money illegally through organizing Cricket betting from punters, he came into contact with main Cricket betting organizer/Bookie by name Remmy R/o. Nagpur, Maharashtra state through him he get for online cricket live match, which provides on-line score ball to ball, as well as betting ratios and used to collect betting amount from the punters clandestinely and remit to main bookie through **google pay/Paytm/Phonepe** and gain illegal easy money.

For organizing betting the accused Khimani Saleem engaged three sub-organizers namely 1)Anwar Akbar Khoja 2)Sandeep Agarwal & 3)Kontham

Abhilash and used to collecting betting amount for ongoing IPL Cricket matches. He having about 10 to 15 punts who are betting amount.

On 01-10-2020 in the night hours accused persons while organizing and accepting betting amount from punters situated at Flat no. 202, 2nd floor, Dwaraka Residency, Indirapuri Railway Colony, Marredpally for **ongoing IPL - 2020** Cricket match held in-between Kings XI Punjab (KXIP) Vs Mumbai Indians (MI) playing at Sheikh Zayed Stadium, Abu Dhabi on tip off raided the gaming house and apprehended them and seized above material.

The apprehended accused persons along with seized material were handed over to S.H.O Marredpally PS for further investigation.

The arrest was made under the supervision of **Sri.P.Radhakishan Rao, Dy. Commissioner of Police**, Commissioner's Task Force, Hyderabad lead by **Sri K.Nageswar Rao, Inspector of Police**, Commissioner's Task Force, North Zone, and SI B.Parameshwar , G.Rajashekar Reddy and North Zone Task Force Team, Hyderabad.
