

Moghalpura Police arrested the following accused persons and 2 Boy juveniles on 06.10.2020 who were involved in mobile phones theft in market areas and places where large number of people gather.

**Particulars of the Accused Persons:**

- 4) Mekala Jagapathi Babu @ Jagath, r/o Abdullahpuramet, R.R.District.
- 5) Thota Pothuraju @ raju, r/o Nagole, Bandlaguda, RR district.
- 6) Ram Chandar Pradhan @ ramu, r/o Nagole, Bandlaguda, R.R.district.

The above mobile theft cases were detected through the efforts of Moghalpura crime teams 26 Mobiles phones were seized from the accused persons, Which also involves a couple of boy juveniles.

According to the evidence collected on record and investigation done so far, the main accused Prashanth formed a gang involved A-2 to A-6 along with BJ-1&2. Under supervision of A-1 Prashanth, the accused persons A-2 to A-6 and BJ-1&2 were move in areas of public gathering areas like markets and commit theft of mobile phones and hand them over to A-1 Prashanth. Their modus operandi is picking phones from the pockets of people who go to busy markets. One of the offenders diverts the attention of the victim, while the other picks the pocket.

The cases were investigated by staff Detective Inspector Moghalpura Ranjit and his team under the supervision of incharge DCP South Zone Sri Gajarao Bhupal, IPS.

**CRICKET BETTING RACKET BUSTED - TWO PERSONS HELD  
SEIZED NET CASH OF Rs. 5,30,000/- AND 02-CELL PHONES.**

The sleuths of Commissioner's Task Force, South Zone Team, Hyderabad along with Mangalhat Police busted cricket betting racket and apprehended two accused persons namely 1) Shankar Singh (**Bookie**) and 2) MD Javeed (**Punter**) and seized net cash of Rs. 5,30,000/-, and 02-cell phones at the instance of accused persons.

**Names of the accused persons:-**

- 1) Shankar Singh, age 34 years, Occ: Business, R/o Mangalhat, Hyderabad
- 2) MD Javeed, age 40 years, Occ: Fruit Business, R/o Chandrayangutta, Hyderabad
- 3) MD Khadeer (**Absconding**)

**Cash of Rs. 5,30,000/- & 02-cell phones.**

**Brief facts of the case:-**

The Prime accused Shankar Singh is a native of Mangalhat, Hyderabad. He resorted to collecting cricket bettings in and around Hyderabad from the punters for make easy and quick money. Earlier he was arrested by Mangalhat and Narsingi Police in betting case. During Indian Premier league (IPL) - 2020 tournament playing at UAE i.e. Delhi Capitals(DC) and Royal Challengers Bangalore (RCB), the accused Shankar Singh main bookie is receiving calls from the punters i.e MD Javeed and MD Khadeer and collecting the betting amounts.

On 05-10-2020, on a tip off that, the accused persons are collecting huge betting amounts from punters in connection with the IPL Cricket match between DC Vs RCB teams. The sleuths of Commissioner's Task Force, South Zone Team, Hyderabad along with Mangalhat Police apprehended the accused persons at Mangalhat, Hyderabad, while the accused persons Shanker Singh and MD Javeed accepting cricket betting over a cell phone by watching the match. Seized net cash of Rs.5,30,000/- and 02-cell phones at the instance of accused persons.

The accused persons along with seized property handed over to SHO Mangalhat police station for further investigation.
