

**PD ACT INVOKED AGAINST PABITRA KUMAR JAYSINGH S/O PRAVAKAR  
JAYSINGH, SNATCHER OF MARREDPALLY POLICE STATION,

Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City issued preventive detention order under the Act No.1 of 1986 against Pabitra Kumar Jaysingh s/o Pravakar Jaysingh, aged about 23 years, Occ: Glass Cleaning Work, r/o H.No.18-482, Mallikarjun Nagar, Malkajgiri, n/o Rasool (V), Sanapadar (M), Begunia Khorda, Odisha State, snatcher of Marredpally Police Station on 21.12.2020.

The detenu Pabitra Kumar Jaysingh s/o Pravakar Jaysingh has been **habitually committing snatchings along with his associate, in an organized manner, in the limits of Hyderabad and Rachakonda Police Commissionerates.**

Malkajgiri Police made efforts and arrested Pabitra Kumar Jaysingh s/o Pravakar Jaysingh on 6.08.2020 in Cr.No.550/2020 of Malkajgiri Police Station and remanded him to judicial custody. The preventive detention order was executed by Marredpally Police on 23.12.2020 and he was lodged in Central Prison, Cherlapally, Medchal-Malkajgiri district.

**PRESS NOTE IN CR No 126/2020 U/s 420, 406, r/w 34 IPC**

CCS Police arrested the accused persons Sanjay Kanodia age: 52 yrs, Smt. Seema Kanodia, age: 48 yrs, and Bheemreddy Shamsundar Reddy, age 40 yrs, who cheated their employees by deducting the amounts from their salaries towards provident fund and TDS and failed to remit the same in their respective accounts in PF and IT.

The accused persons are the directors of M/s Pervacio India Pvt. Ltd., which was a software company and having about (61) employees. The accused persons deducted the amount of nearly Rs 1.00 crore from their employee salaries towards provident fund and TDS and failed to remit the same in their respective accounts with the concerned department.

The accused were arrested on 04-01-2020 at CCS, DD, Hyderabad and is being produced before the Hon'ble Court to remand for judicial custody.

The case is being investigated by Sri K. Ramakrishna, Sub-Inspector of Police, WCO Team-X, CCS under the supervision of Sri R. Govinda Reddy, Inspector of Police, WCO Team-X and Sri K.N. Vijay Kumar, ACP, Div-D, and Sri Mahender, Addl. Dy. Commissioner of Police, EOW, CCS.
