**NOTIFICATION**

In exercise of the powers conferred upon me under section 21(1) (b) of the Hyderabad City Police Act, I, Anjani Kumar, IPS, Commissioner of Police, Hyderabad City, hereby notify that as per the request of Executive Engineer, Division No. 4A, GHMC for **Remodelling of Drain by Construction of RCC Box Drain/RCC Open Drain from Farhat Nagar Junction towards 17-5-349 in Dabirpura Div-Package-I** and therefore for the safety of general public the following traffic diversions will be enforced for a period of (01) month w.e.f 06-01-2021 to 05-02-2021.

**DABIRPURA FLYOVER TOWARDS APAT JUNCTION.**

**A)** The Traffic Coming from Dabirpura Flyover towards APAT Junction will be diverted Via Jabbar Hotel, Shaik Fayaz Kaman (Right Turn), Ganga Nagar Nala, Etebar Chowk Jn (Right Turn) APAT Junction.

**B)** The traffic coming from Dabirpura Flyover towards APAT Junction will be diverted Via New Ali Café (Right Turn) Komatwadi Left Turn Noorkhan Bazaar, APAT Junction.

**APAT JUNCTION TOWARDS DABIRPURA FLYOVER.**

**A)** The traffic Coming from APAT Junction towards Dabirpura Flyover will be diverted at Shuttaria Mosque (Left Turn), Noor Khan Bazaar, Komatwadi (Right Turn) New Ali Café Dabirpura,(Left Turn) Dabirpura Flyover..

**B)** The traffic coming from APAT Junction towards Chanchalguda will be diverted at Dabirpura Kaman (Right Turn), Success School, Ganga Nagar Nala (Left Turn) Bada Bazaar, Yakutpura Railway Station, Chanchalguda.

All the Citizens are requested to take alternate routes to reach their destinations and avoid the above routes during the above period and cooperate with the Traffic Police.

**PD ACT INVOKED AGAINST DILIP DALEI S/O JOGI DALEI, SNATCHER  
OF MARREDPALLY POLICE STATION, NORTH ZONE, HYDERABAD**

Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City issued preventive detention order under the Act No.1 of 1986 against Dilip Dalei s/o Jogi Dalei, aged about 19 years, Occ: Glass Cleaning Work, r/o H.No.18-482, Mallikarjun Nagar, Malkajgiri, n/o Naraganga (V), Cuttak (M), Odisha State, snatcher of Marredpally Police Station on 29.12.2020.

The detainee Dilip Dalei s/o Jogi Dalei has been **habitually committing snatchings along with his associate, in an organized manner, in the limits of Hyderabad and Rachakonda Police Commissionerates.**

Malkajgiri Police made efforts and arrested Dilip Dalei s/o Jogi Dalei on 6.08.2020 in Cr.No.550/2020 of Malkajgiri Police Station and remanded him to judicial custody. The preventive detention order was executed by Marredpally Police on 29.12.2020 and he was lodged in Central Prison, Cherlapally, Medchal-Malkajgiri district.

CONDUCTED RAID ON ONE KITE & MANJA SELLING SHOP IN  
MANGALHAT PS LIMITS AND CASE WAS BOOKED FOR ILLEGAL  
POSSESSION OF CHINESE MANJA

Today i.e., 05.01.2021 at 1400 hrs, on receipt of credible information Police Mangalhat team consists of Sri J.Jagan, SI & Sri G.Venkateshwarlu, SI and staff conducted raid on one Kites selling shop styled as Yash Patag Shop at Aryasamaj, Mangalhat, Hyderabad and apprehended one person by name Rakesh Singh, S/o late Prakash Singh, aged 34 yrs, Occ: Kites selling business, R/o.H.No.14-11-259/B, near Aryasamaj, Mangalhat, Hyderabad with illegal possession of banned (59) NOs. of Synthetic nylon coated threads (Chinses Manja) babins styled as MONO FIL GOLD. A case was registered against said accused vide Crime No.03/2021, U/s.188, 336 IPC, Sec.5 & 15 of Environmental Protection Act-1986 of P.S Mangalhat and case is under investigation.

The General public are requested not to purchase and entertain this harmful Chinese Manja during this Sankranthi Festival as it is likely to cause grievous injury and inconvenience to animals including birds as well as human beings.
