GOLCONDA POLICE APPREHENDED TWO PERSONS WHO INVOLVED IN SNATCHING OF
MOBILE PHONE NEAR PRESIDENT GARDEN, SHAIKPET, HYDERABAD.

BREIF FACTS:

The Mobile phone Snatching case occurred on 18.12.2020 at 2340 hrs near President Garden, Shaikpet, Hyderabad while complainant was going on the way to hostel by foot. The accused A1 & A2 came in Passenger Auto Br.No.TS-13-UB-1979 and stopped near the complainant and asked for Auto but complainant denied, A2 took the auto to a little distance and stopped, whereas A1 got down and snatched the mobile phone from complainant's shirt pocket and fled away from spot.

Modus Operendi:

The accused A1 & A2 are close friends and addicted to Ganja, Liquor. A1 habitual offender involved in Bodily, Property and Communal cases. A1 & A2 met at Mehdipatnam X road, Hyderabad at night time where they consumed liquor and proceeded towards Dargha road on A2's Passenger Auto TS-13-UB-1979. When A1 & A2 reached near President Garden, Shaikpet, Hyderabad meanwhile found complainant who was going by foot. A1 noticed the mobile phone in the pocket of complainant. Instantly they hatched plan and stopped the Auto near to complainant and asked for Auto but complainant denied, A2 took the auto to a little distance and stopped, A1 got down and snatched the Red MI Note-6 pro mobile phone from complainant's pocket and fled away from there.
