

**APPREHENDED HOUSE BURGLAR - RECOVERED GOLD ORNAMENTS WG.
ABOUT 200 GRAMS, ONE AUTO & NET CASH OF RS. 3,000/-
ALL WORTH ABOUT 10.5 LAKHS.**

On 13-01-2021, the sleuths of **Commissioner's Task Force, South Zone Team**, Hyderabad along with Santhosh Nagar Police apprehended one habitual house burglar by name **Habeeb Azmath** and detected **(03)** property offence cases in Hyderabad and recovered **gold ornaments Wg. About 200 grams, one Auto & net cash of Rs. 3,000/- All Worth Rs. 10.5 lakhs** at the instance of accused person.

Details of accused:-

1. **Habeeb Azmath**, S/o Habeeb Hussain, age 28 yrs, R/o Kishanbagh, Hyderabad.
2. **Shaik. Sharooq**, S/o Sk. Wajid, aged about 24 yrs., Occ: Auto Driver, R/o Chaderghat, Beside Muslim Maternity Hospital, Chaderghat, Hyderabad.(**Absconding**)

Property seized:-

1. **Gold ornaments Wt about 200 grams.**
2. **Auto bearing no. TS11UA7331**
3. **Net cash Rs. 3000/-**

Criminal background of the Prime accused:-

The accused **Shaik Sharooq** involved in more then **(30)** cases in various Police Stations of Hyderabad, Cyberabad and Rachakonda Commissionerates.

Brief facts of the accused.

The accused Habeeb Azmath is an Auto Driver, he is leading his life with his family members at Bahadurpura, he is not comfortable with the earnings obtained from auto driving. He turned his attention towards committing property offences to full fill his desires, mean time he came into contact with one habitual offender by name **Shaik Sharooq** who is residing at Chaderghat. They both hatched a plan and committed **(3)** property offences in the limits of Santhoshnagar and Falaknuma Police Stations.

Modus Operandi:-

The accused **Habeeb Azmath** and Shaik Sharooq wake up in the early morning hours and targets the houses of devotees of Muslim Community who went to perform Fazar Namaj in the masjids duly keeping open their house main door without bolt, the accused also targets the houses, which the doors are latch from outside. The main accused **Sharooq** enters into the latched door houses/door open houses, mean time other accused Habeeb Azmath watch over the surrounding areas to know the movements of the devotees. By taking chance they commit theft of valuable items like gold, cell phones, cash etc. after committing offence they sped away from the spot and share the stolen property equally for further disposal.

Today, basing on credible information, the South Zone Task Force, Hyderabad along with Santhoshnagar Police apprehended the above accused and recovered the stolen property. The apprehended accused and seized property handed over to **SHO Santhoshnagar** Police for taking further action.

Brief facts:

- The accused SHAIK ABDUL JAFFAR @ AHMED @ SAFIUDDIN is a native of Hyderabad and presently residing at Tolichowki. The accused was habituated to all kind of social vices and decided to earn easy money by committing offences.
- Since the accused was caught in 66 cases by the Police in Telangana state he changed his plan to commit offences in other states. In this process he went to Andhra Pradesh and committed offences in Guntur and Kurnool Districts.

Acting on the tip off the Commissioner's Task Force, East Zone Team, Hyderabad city apprehended the above accused person along with the stolen property and stolen bike and Recovered 23 Tulas of Gold & Diamond ornaments Worth Rs.12,00,000/-, One Honda Activa bike and Net Cash Rs.10,000/- from his possession.

The arrested accused along with seized property was handed over to SHO, Golconda PS, for taking further action.
