

**PD ACT INVOKED AGAINST ABDUL SAMAD S/O ABDUL WAHEED,
ARMS OFFENDER OF LANGER HOUSE POLICE STATION,
WEST ZONE, HYDERABAD.**

Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City issued preventive detention order under Act No.1 of 1986 against Abdul Samad s/o Abdul Waheed, **Arms Offender of Langer House Police Station** on 30.12.2020.

Abdul Samad s/o Abdul Waheed, aged about 25 years, Occ: Furniture work, r/o behind Galaxy theatre, Hakeem Shah colony, Tolichowki, Hyderabad has **committed a heinous offence of double murder along with his associates by using lethal and prohibited arms in public place in an organised manner in the limits of Hyderabad Police Commissionerate.**

He has earlier committed an offence of hurt and criminal intimidation in the limits of Hyderabad Police Commissionerate. His activities are creating large scale fear, terror and panic among the public thereby adversely affecting the public order.

Langer House Police arrested the accused Abdul Samad s/o Abdul Waheed, aged about 25 years, Occ: Furniture work, r/o behind Galaxy theatre, Hakeem Shah colony, Tolichowki, Hyderabad on 8.6.2020 in Cr.No.102/2020 U/s 147, 148, 302 r/w 149 IPC and Section 25 (B) (1) of Indian Arms Act of Langer House PS.

The Preventive Detention Order was executed on him on 3.1.2021 and he was lodged in Central Prison, Chanchalguda, Hyderabad.

(A1 was taken into custody on 15-01-2021 at his house at OM Nagar, SPR Hills Yousfugda Hyderabad)

A2] Abhishek **(A2 is absconding)**

Seized Material:

One 15 years old Bonsai Plant

Modus Operand:

The accused person A-1 is a Maison worker. While the accused roaming in Jubilee Hills area, he observed the bonsai plants several times in front of residence of IPS officer (Rtd), he decided to commit theft of that bonsai plant which was placed in front of Main gate of Plot No 406A, Road No 18, Jubilee Hills. Accordingly on 10.01.2021 at about 03.10 hrs, A-1 & A-2 came to Road No 18 on A-2's bike and committed theft of that Bonsai plant, with a view to sell it to interested customers.

In this case verified the CCTV footages of enroute, identified the accused with the informants and today arrested the A-1 and recovered the stolen Bonsai Plant.

Appeal to Public:

It is requested to install CCTV at each and every house & establishments to prevent the offences and also to detect the offences and for speedy recovery of stolen property as well.
