

**APPREHENDED INTERSTATE ATTENTION DIVERTING OFFENDER - SIEZED 13  
TULAS OF GOLD, WORTH OF RS. 6.5 LAKHS.**

The sleuths of Commissioner's Task Force, South Zone Team, Hyderabad along with Mahankali Police apprehended one interstate most wanted **(since 2019 to till date)** diverting attention offender in Telangana and Maharashtra States, who committing offences by diverting the poor family ladies in the pretext of free distribution of sarees. Total detected (17) cases and seized (13) Tulas of Gold ornaments at the instance of the accused. All worth of **Rs. 6.5 Lakhs.**

## **Modus Operandi**

Accused **Pathan Yasin Khan** is a native of Ahmadabad, Gujarat State. Currently he is doing readymade dress selling business, due to loss in his business; he hatched a plan to commit theft of Gold ornaments by diverting the attention of the lady victims to earn easy money. About five years back he committed attention diversion offences in Gujrath State and went to jail from Vadodara police. After releasing from jail he did not changed his attitude and hatched a plan to commit offences other than Gujrath state in order to hide his identity.

As per his plan he frequently visit different cities of other states like Maharashtra and Telangana, where he visit the busy markets and select the targets like single ladies (particularly middle class people) and introduce them as he is working under high profile people and request them to attend free saree distribution at his owners house nearby the place. Whoever believes his words, he took them some distance and request to remove the gold ornaments and to keep in a paper to like poor people. Otherwise, they will reject to gift the saree. Meantime he will divert the mind of said victim lady and he collects the gold ornaments, act as keeping in a 500 note or in paper. Immediately he diverts the victim and handed over another cover which contains stones or cotton paper pieces. Later he diverts the lady to collect saree and he escape from the spot with gold ornaments. Like viz., he also committed offences in the limits of **Rajestan, Karnataka and Madyapradesh States** are yet to be verified.

Basing on credible information, the South Zone Task Force, Hyderabad along with Mahankali Police apprehended the above accused and seized Gold ornaments. The arrested accused along with seized property handed over to **SHO Mahankali** for taking further action.
