

HELD ONE NIGERIAN DRUG PEDDLER - SEIZED (04) GRAMS OF COCAINE

On 02-10-2021, the sleuths of Commissioner's Task Force, South Zone Team along with Panjagutta Police apprehended one Nigerian national at GVK Mall Panjagutta, Hyderabad, who is found in possession of Narcotic substance (Cocaine) and who supplying to the needy customers in limits of Hyderabad and Cyberabad. Seized 04 grams of Cocaine and One Honda Activa at the instance of accused.

Particulars of accused:-

- 1) Daniel Ayotunde Olamide S/o Daniel Olurei Joseph, aged 33 yrs, Occ: Student R/o Near Dream Vally, Friends Colony, Shaikpet, Tolichowki, Hyderabad, N/o No.60, Ijebu City, Lagos State, Nigeria.--
- 2) John Paul, Aged about 37 yrs, N/o: Nigeria R/o Delhi (Absconding).

Property seized :-

- 1) 04 grams of Cocaine
- 2) One Honda Activa

The brief facts of the case :-

The accused Daniel Ayotunde Olamide is native of Ijebu City, Lagos State, Nigeria. In the year 2014 he came to Hyderabad, India on student VISA and pursuing degree from Vivekananda Degree College, Kukatpally. At present he is residing Near Dream Vally, Shaikpet, Tolichowki, Hyderabad. Daniel addicted to drugs, mean time he came in contact with one person by name John Paul, R/o Delhi who is a Nigerian National and habitual drug peddler. The both hatched a plan and started drug supplying in and around Hyderabad city. Subsequently, Danile arrested by Langarhouse Police in drugs supplying case and released from jail. After releasing from jail he didn't chang his behaviour and mindset, again he started supplying drugs to needy customers with the help of John Paul. The Danile used to deliver Drugs to the needy customers in Hyderabad by charging an amount of Rs.8, 000/- to 10,000/- per (01) gram of cocaine, after selling of drugs they will share amount equally.

On 02-10-2021, on tip of information, the South Zone Task Force team, Hyderabad along with Panjagutta Police apprehended the above persons at GVK Mall, Panjagutta, while he trying to sell contraband Narcotic drug (Cocaine) to the needy customers. Seized (04) grams of Cocaine, and One Honda Activa at the instance of accused.

The arrested accused along with seized property were handed over to SHO, Panjagutta PS, for further investigation.

The above arrests were made by Sri. S. Raghavendra, Inspector of Police, South Zone and SIs S/Sri V. Narender, N. Srishylam, Mohd Thakiuddin, K Chandra Mohan & Staff of South Zone Task Force, Hyderabad City along with Panjagutta Police, Hyderabad.
