

ORGANIZED CRICKET BETTING RACKET BUSTED – 04 HELD

On credible information the sleuths of Commissioner's Task Force, North Zone Team, Hyderabad busted cricket betting racket & organized gaming house situated at Risalgunj, in the limits of Afzalgunj PS and apprehended (04) accused person while organizing cricket betting through online betting sites i.e **Tripal7.com, subh999.com, radheexchange.com, Skyexchange.com** and accepting betting amount from punters for ongoing cricket betting & other online betting games for earn easy money illegally.

1. Rs. 2,03,000/- (Betting amount)
2. Cell phones -04 installed betting sites and used for online betting amount

➤ **FACTS OF THE CASE:-**

The accused Maya Chandrakanth is residing in the limits of Afzalgunaj, Hyderabad. He is habit of betting amount in the Cricket matches and he got knowledge on the betting, to gain easy money illegally he came into contact with Host by name Mahadev @ Mahadevbook R/o. Maharashtra state (www.mahadevbook.com) and organizing online betting in an organized manner at above said premises through online betting sites i.e 1) **Tripal7.com**, 2) **subh999.com**, 3) **radheexchange.com, Skyexchange.com**.

He offers types of bets from punters such as singles, accumulators, system and chain bets and accepting betting on Live **Cricket matches, online games & sports**: i.e **Teen Patti (Play cards), Casino games**, football, tennis, basketball etc.

The accused Maya Chandrakanth used to creating login ID & Password, joins the agents/punters and send the ID number to punters, accepting betting amount from them through online and offline mode or over PhonePe, Googlepay amount from them. The Punters who joins in the account, they bets the amount on pints basis for playing the betting game and the punter who wins the game receives the amount directly or indirectly and the Host gets the percentage from the winning amount from the agents.

The main organizer Maya Chandrakanth was engaged his agents/punters by name 1) Vuppala Shashank, 2) Rajneesh Kumar, 3) Pavan Agarwal and others with them have been contact punters who are having habit of bettings, collecting betting amount and remit to main organizer bank account or made online transactions and the main organizer pay the commission to organizers @ 3 to 5% on betting amount.

Yester night while the organizer Maya Chandrakanth along with his associates namely Vuppala Shashank, Pavan Agarwal, Rajneesh Kumar and others are organizing and accepting cricket betting amount from punters on tip off information apprehended them.

The apprehended accused persons along with seized material were handed over S.H.O Afzalgunj PS for further taking necessary action. Vide **Cr.No. 448/2021**, U/s. 3&4 of TS Gaming Act of Afzalgunj PS.

THREE-MEMBERS DRUG PEDDLING GANG HELD AND SEIZED 120 ml OF HASH OIL & 600 gm OF GANJA

On 08-10-2021 in the evening hours the sleuths of Commissioner's Task Force, Central Zone Team, Hyderabad, on credible information raided one house situated at H.No.9-8-68/1, Ground Floor, Road No.2, Street No. 3, Maruthi Nagar, Santhosh Nagar, Hyderabad and apprehended three Drug peddlers by name **1.** Tirupur Rama Swamy Pavan Kalyan @ TR Pavan Kalyan @ Pavan, **2.** Kussumalla Rakesh @ Rakesh @ Nani and **3.** Purusharani Pramod Kumar Goud @ Pramod and seized **Hash Oil** weighing about **120 ml** in 23 small plastic boxes, **Ganja** weighing about **600 gm**, One Two- wheeler and Three Mobile phones from their possession.

Brief Facts:-

Acting on a tip off, the sleuths of Commissioners Task Force, Central Zone Team, Hyderabad, apprehended three persons who is in illegal possession of Narcotic Drug i.e., Hash Oil and Ganja at H.No.9-8-68/1, Ground Floor, Road No.2, Street No. 3, Maruthi

Nagar, Santhosh Nagar, Hyderabad and seized **Hash Oil** weighing about **120 ml** in 23 small plastic boxes, **Ganja** weighing about **600 gm**, One Two- wheeler and Three Mobile phones from their possession.

On enquiry it came to know that the accused Kussumalla Rakesh @ Rakesh @ Nani & Purusharani Pramod Kumar Goud @ Pramod are procuring the Narcotic substances from Sileru and Araku, Andhra Pradesh. They are procuring and bring the Narcotic substances to city via Railways and Road Transport system clandestinely and selling the same to customers in Hyderabad with the help of Tirupur Rama Swamy Pavan Kalyan @ TR Pavan Kalyan @ Pavan and selling small box of Hash Oil for about Rs. 2000/- to Rs. 2,500/- and Ganja small packet for about Rs. 150/- to 250/- as such gaining illegal profits. On further enquiry it is came to know that the accused Tirupur Rama Swamy Pavan Kalyan @ TR Pavan Kalyan @ Pavan is wanted in Cr. No. 158/2021 U/s 8 (c) R/w 20 (b) (ii) (A) of NDPS Act of Tapachabutra PS.

Previous History:

The accused Tirupur Rama Swamy Pavan Kalyan @ TR Pavan Kalyan @ Pavan was arrested in Cr. No. 07/2021 U/s 8 (c) r/w 20 (b) of NDPS Act of Dummugudem PS, Bhadradri Kothagudem.

The accused Purusharani Pramod Kumar Goud @ Pramod was arrested in Cr. No. 66/2020 U/s 8 (c) r/w 20 (B) (II) of NDPS Act of Panjagutta PS, Hyderabad.

The arrested accused along with seized property were handed over to SHO, Kanchanbagh PS, for further investigation.
