

**PD ACT INVOKED AGAINST IMRAN KHAN @ IMMUS/O MOHAMMED KHAN,
ROWDY ELEMENT (GOONDA) OF HABEEBNAGAR POLICE STATION,
WEST ZONE, HYDERABAD.**

Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City issued preventive detention order under Act No.1 of 1986 against **Imran Khan @ Immus/o** Mohammed Khan, (Rowdy Element) Goonda of Habeebnagar Police Station on 22.10.2021.

Imran Khan @ Immus/o Mohammed Khan, aged about 24 years, Occ: Old furniture work, r/o H.No.5-5-275, Gandhi Bhavan, Patel Nagar, Hyderabad, **Rowdy element** earlier involved in several offences including **attempt to murder** in the limits of Hyderabad and Warangal Police Commissionerates and he was detained under the Act No.1 of 1986 in August, 2019. Subsequently, he was released from jail after 2 months in preventive detention.

After his release from preventive detention, there is no change in his attitude of committing crime and committed 2 more offences **including attempt to murder, criminal intimidation and extortion in the limits of Hyderabad Police Commissionerate along with your associates in an organised manner.** His activities are causing widespread fear, terror and panic among the public, thereby adversely affecting the public order.

Habeebnagar Police arrested Imran Khan @ Immus on 29.7.2021 in Cr.No.149/2021 u/s 384, 341 r/w 34 IPC & Section 25 (1-A) of Arms Act of Habeebnagar Police Station. The Preventive Detention Order was executed on him on 22.10.2021 and was lodged in Central Prison, Chanchalguda, Hyderabad.

**APPREHENSION OF ACCUSED WHO CHEATED SEVERAL JOB ASPIRANTS UNDER THE
PRETEXT OF PROVIDING JOB VISAS AND PLACEMENTS IN THE USA AND COLLECTED HUGE
AMOUNT ABOUT Rs. 4 CRORES IN COLLUSION WITH OTHERS IN CRIME NO. 162/2021
U/SEC 406, 420 IPC**

On 29.10.2021 the police personal of FICN team, CCS-DD, Hyderabad apprehended the accused A1-Tippula Reddy Bhaskar Reddy at C. Ramapuram (v), Ramachandrapuram, (m), Chittoor Dist on the charge of cheating to job aspirants under the pretext of providing Job VISA and placements in the USA and collected the huge amount about 4 Crores from them and brought him to CCS on transit warrant and produced before the Hon'ble court on 01.11.2021

On the complaint of Sri. T. Krishna Prakash ,Hyderabad registered a case at CCS, DD Hyderabad on 01.10.2021 in Cr. No. 162/2021 u/s 406, 420 IPC and investigated by K. Mahesh SI of police FICN Team, CCS. Hyderabad.

The accused native of Mudiyamvaripalli (v), Kalakada (m), Chittoor Dist AP State, previously. He established a computer training institute in Ameerpet, Hyderabad in the name of "Domain Network Zone" and induced the students on the pretext of providing job opportunities & VISAs in the USA and collected the huge amount about 4 Crores from the job aspirants with the help of other accused and failed to provide Job VISAs and avoided to return the collected amount.
