

**PRESS NOTE**  
**ARREST OF ONE ACCUSED IN MURDER CASES**

ONE PSYCHOPATH KILLER ARRESTED BY HABEEBNAGAR PS OF HYDERABAD CITY.

**THE DETAILS OF ACCUSED:**

MOHD QADEER S/O MOHD WAHEED, AGE: 48 YEARS, OCC: LABOR WORK AND AUTO DRIVER, R/O SAFDAR NAGAR, BORABANDA, HYDERABAD. N/O BAGDAL (VILLAGE), HUMNABAD (THALUK), BIDAR, KARNATAK STATE.

Facts of the case are that, on 01-11-2021 at 1045 hours a complaint was received from Sri. Sunil Prabhakar S/o Late Prabhakar, age 60 yrs Occ: Helper at Bharath Tiffin Center situated at Tabanda X Road R/o Backside of Gas Patrol Pump. Bazarghat, Nampally, Hyderabad in which he stated that he is working as a helper at Bharath Tiffin Center since past 5 years. Daily early morning he goes to Tiffin centre at about 04:00 hours for work. On 01-11-2021 in the early morning at about 0400 hours as usual he came to Tiffin Centre and saw one unknown male person aged about 35-40 yrs was lying in pool of blood in front of Tiffin Centre. Immediately he informed to the police for taking necessary action.

A case in Crime No. 244/2021 U/s 302, 394 IPC has been registered and investigation taken up.

During the course of investigation it was identified that one unknown person was sleeping in front of the hotel and some unknown person aged about 35-40 yrs came to the said person while he was sleeping and without any reason he hit that person on his head with a stone slab twice due to which he died on the spot. Later the said unknown person took the money from the Jacket of deceased and left the spot.

Special teams were formed to nab the accused. Based on Technical evidence and Human intelligence the accused Mohd Qadeer, age 48 yrs was apprehended.

**MODUS OPERANDI:**

As per the confession of the accused person, it is revealed that he came to Hyderabad in search of live hood and started working as a casual labour and living in Borabanda locality and he is a native of Bagdal (Village), Humnabad (Thaluka), Bidar, Karnataka State. The accused is addicted to alcohol and he is unable to meet his financial needs with his meagre income. He sleeps on the footpath at Ek Minar Mosque, Nampally during night times.

**PREVIOUS CASES:-**

Investigation has revealed he is also involved in

**1) Cr.No. 130/2017 U/s 379 IPC of PS Habeebnagar**

**2) Cr No: 173/2017 U/s 379 IPC of PS Habeebnagar.**

In both cases he was convicted for (06) months.

And was also involved in a murder case in:-

**3) Crime No. 311/2019 U/s 302 IPC of Nampally Police Station** in which he murdered a beggar by hitting on his head with a boulder.

**4) Crime No. 222/2021 U/s 174 Cr.PC of Habeebnagar P.S:** On 15-10-2021 in the morning hours he came to Murgi Market, Nampally and tried to take some amount from a sleeping beggar on the footpath. When the beggar woke up and resisted, the accused pushed him due to which he fell down in supine position and received bleeding head injury and died later.

**PRESENT CASES:-**

On 31-10-2021 at 2200 hrs the accused went to Nampally railway station and consumed cheap liquor and came to Tabanda X road and was waiting to commit theft of net cash from the footpath dwellers. He found a person and asked for match box, when the said person woke up the accused demanded him to give some cash, but he refused, he immediately took a piece of slab and hit on the person head and took Rs. 150/- and one quarter bottle from his pocket and went away (**Crime No. 244/2021 U/s 302, 394 IPC of Habeebnagar PS**) from there the accused went to Nampally station area at about 3.30 am where he found a known person by name Khaja who was sleeping in an Auto Trolley and asked him to give some space to sleep, when he refused, the accused took a stone and hit on his head due to which he died (**Crime No. 284/2021 U/s 302 IPC of Nampally PS**).

Today i.e. on 05-11-2021 in the morning hours he was arrested at Nampally Public Gardens by Habeebnagar staff lead by M. Narender, Inspector of Police, Habeebnagar under the guidance of ACP, Asifnagar, Sri Siva Maruthi and overall supervision of Sri A.R. Srinivas, IPS, Jt. Commissioner of Police, West Zone, Hyderabad.

**PD ACT INVOKED AGAINSTMOHAMMED KHADAR S/O MOHAMMED  
RAHEEM, DRUG OFFENDER OF FALAKNUMA POLICE STATION,  
HYDERABAD**

Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City issued a preventive detention order under the Act No.1 of 1986 against Mohammed Khadar s/o Mohammed Raheem on 28.10.2021.

The detenu Mohammed Khadar s/o Mohammed Raheem, aged about 27 years, Occ: cab driver, r/o H.No.16-9-749/39/2, race course road, Papaiah Basthi, Old Malakpet, Hyderabad n/o Erraram village of Nalgonda district, Telangana State was peddling Narcotic Drugs among the people **in the limits of Hyderabad Police Commissionerate** with his associates in an organized manner. He has developed a widespread network, wherein he uses cell phones and other information technology devices to escape police observation.

He committed an offence in peddling of Narcotic Drugs among the people in the recent past and his illegal and highly dangerous activities in peddling of Narcotic Drugs among the people has been endangering the lives of youth and innocent people causing irreparable damage to the body organs including the Central Nervous System, thereby crippling the mental and physical health of the people addicted to drugs. His activities were prejudicial to the maintenance of public order and public health at large.

Falaknuma Police arrested the detenu Mohammed Khadaron 30.4.2021 in Cr.No.111/2021 u/s 8 (c) r/w 20 (b) of NDPS Act, 1985 of Falaknuma Police Station and remanded him to judicial custody. The preventive detention order was executed on him **on 29.10.2021** and he was lodged in Central Prison, Chanchalguda, Hyderabad.

**TRAFFIC ADVISORY**

In view of the **Sadar Utsav Mela** which will be celebrated at YMCA, Narayanaguda on 06-11-2021, from 7 PM to 5 AM on 07-11-2021, the movement of vehicular traffic will be diverted at the following places and routes:

1. Vehicular traffic will not be allowed from Kachiguda X Roads towards YMCA, Narayanaguda. It will be diverted towards Tourist Hotel, Kachiguda.
2. Vehicular traffic will not be allowed from Vittalwadi X Roads towards YMCA, Narayanaguda. It will be diverted towards Ramkoti X Roads.
3. Vehicular traffic will not be allowed from Rajmohallah. It will be diverted towards Ramkoti X Roads at SABOO SHOP Point.
4. Vehicular traffic will not be allowed from Reddy College (St. No. 8). It will be diverted towards Barkatpura.
5. Vehicular traffic will not be allowed from Old Barkatpura Post Office towards YMCA, Narayanaguda. It will be diverted either towards Crown Café or Lingampally.
6. Vehicular traffic will not be allowed from the Old Excise Office lane towards YMCA, Narayanaguda. It will be diverted towards Vittalwadi.
7. Vehicular traffic will not be allowed from Barkatpura Chaman towards YMCA, Narayanaguda. It will be diverted towards Barkatpura X Roads or towards Tourist Hotel.
8. Vehicular traffic will not be allowed from Brilliant Grammar School (Near Narayanaguda Flyover) towards Reddy College. It will be diverted towards Narayanaguda X Roads.

General public are requested to avoid above roads and take alternate routes to reach their destination and cooperate with the Hyderabad Traffic Police.
